1.0 **EXECUTIVE SUMMARY**

1.1 The purpose of this report is to consider an application to vary a Premises Licence under the provisions of the Licensing Act 2003.

3.0 APPLICATION

3.1 The applicant has requested to remove the Supply of Alcohol and Recorded Music from the Premises Licence and to include the following Licensable Activity. The applicant also seeks to extend the Hours the Premises are Open to the Public:

Late Night Refreshment

Sunday to Thursday 23:00 to 00:00 Friday and Saturday 23:00 to 01:00

Hours Open to the Public

Sunday 12:00 to 00:00 Monday to Thursday 11:00 to 00:00 Friday and Saturday 11:00 to 01:00

- 3.2 The applicant has requested to extend Late Night Refreshment and Hours Open to the Public by 30 minutes on Bank Holidays.
- 3.3 The applicant has also requested to remove the following conditions from the Premises Licence which relate to the Supply of Alcohol:
 - No supply of alcohol may be made under the premises licence:
 - a) at a time when there is no designated premises supervisor in respect of the premises licence, or
 - b) at a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended.
 - Every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.
 - All staff have received drugs awareness training and basic understanding of the law relating to alcohol.
 - No children will be allowed on the premises unless accompanied by an adult.
 - Staff have received training as to under age drinking.

4.0 PROMOTION OF LICENSING OBJECTIVES

- 4.1 Applicants are required to submit as part of their application an operating schedule that sets out how they will conduct/manage their business in accordance with the four Licensing Objectives. A copy of the full application detailing the steps proposed by the applicant is available.
