5.2 The applicant has also requested to remove the following conditions currently imposed on the Premises Licence:

- There must be a duty Manager and Supervisor working every evening from 19:00
- All the Managers and Supervisors must be trained and are designated safety stewards
- Two SIA Registered Door Supervisors must be employed from 23:00
- Measures must be in place to ensure Duty Managers and Supervisors offer to call taxis for customers, free of charge. Customers must wait for taxis in either of the two vestibule areas.
- The premises must be part of an initiative with Merseyside Police and Business Crime Direct which provides a radio link between businesses in the vicinity of the premises to aid crime prevention.
- All Managers and Supervisors must have obtained an NVQ qualification in customer service.
- The Duty Manager and a senior supervisor must monitor the entrance to the premises from 23:00 Monday to Saturday and from 22:30 on Sundays. The Duty Manager and Senior Supervisor must ensure that customers leave the premises quietly and are not carrying bottles or glasses from the premises.

The applicant has proposed to include the following conditions on the Premises Licence if the variation is granted:

- Staff must ensure that customers leave the premises quietly and are not carrying bottles or glasses from the premises.
- Two SIA Registered Door Supervisors must be on the premises from 12midnight on nights the premises is supplying alcohol beyond 12midnight.

6.0 PROMOTION OF LICENSING OBJECTIVES

6.1 Applicants are required to submit as part of their application an operating schedule that sets out how they will conduct/manage their business in accordance with the four Licensing Objectives. A copy of the full application is available.

- Exclude a licensable activity from the scope of the Licence.
- Remove the Designated Premises Supervisor.
- Suspend the Licence for a period not exceeding three months.
- Revoke the Licence.

The licensing authority may decide that no action is necessary if it finds that the review does not require it to take any steps necessary to promote the licensing objectives.

- 5.1 An application has been received from Merseyside Police to review the Premises Licence for the premises known as Cheapest Booze, 7 Dawpool Drive, Bromborough. The Licensing Sergeant has advised that the grounds for review are in relation the Premises being linked to criminal activity and alcohol being sold to a person under the age of 18 years. The Licensing Sergeant considers that the criminal activity linked to these premises and the alcohol being sold to an underage person seriously undermines the Licensing Objectives in particular the prevention of crime and disorder and the protection of children from harm.
