- 2.2 The Licensing Act 2003 Sub-Committee may, having regard to the application for review and any relevant representations, take such of the following steps as it considers necessary for the promotion of the licensing objectives:
  - Modify the Conditions of the Licence.
  - Exclude a licensable activity from the scope of the Licence.
  - Remove the Designated Premises Supervisor.
  - Suspend the Licence for a period not exceeding three months.
  - Revoke the Licence.

The licensing authority may decide that no action is necessary if it finds that the review does not require it to take any steps necessary to promote the licensing objectives.

#### 1.0 EXECUTIVE SUMMARY

1.1 The purpose of this report is to consider an application for a Premises Licence under the provisions of the Licensing Act 2003. The application is made by Ali Yesildag and relates to the premises known as the Paradise Pizza and Kebab Shop, 110 Wallasey Road, Wallasey.

#### 2.0 BACKGROUND AND KEY ISSUES

2.1 These premises currently have a premises licence with the following hours:

#### **Late Night Refreshment**

Sunday to Thursday 23:00 to 01:00 Friday and Saturday 23:00 to 03:00

#### **Hours Open to the Public**

Monday to Thursday 15:00 to 01:00 Friday and Saturday 15:00 to 03:00 Sunday 16:00 to 01:00

#### 3.0 APPLICATION

3.1 The application for the grant of a new Premises Licence is as follows:

#### Sale by Retail of Alcohol

Sunday to Thursday 17:00 to 01:00 Friday and Saturday 17:00 to 04:00

Alcohol sales made after 23:00 would be for delivery orders only

#### **Hours Open to the Public**

Sunday to Thursday 17:00 to 01:00 Friday and Saturday 17:00 to 04:00

#### **Late Night Refreshment**

Sunday to Thursday 23:00 to 01:00 Friday and Saturday 23:00 to 04:00

3.2 Due to the change in the way these premises are to be operated the applicant has applied for the grant of a new Premises Licence. If this application is granted, the existing Licence will be surrendered.

#### 4.0 PROMOTION OF LICENSING OBJECTIVES

- 4.1 Applicants are required to submit as part of their application an operating schedule that sets out how they will conduct/manage their business in accordance with the four Licensing Objectives. A copy of the full application is available.
- 4.2 Members of the Licensing Act 2003 Sub-Committee are advised that the proposals set out in the operating schedule may become conditions of licence should the licence be granted.

#### 5.0 RELEVANT REPRESENTATIONS

5.1 The following Representations have been received in respect of the above application.

#### **Interested Parties**

In respect of this application, a representation has been received from Central Liscard Area Residents Association. A petition has also been received signed by 52 local residents. Two representations have also been from local residents. The representations relate to anti-social behaviour and noise nuisance caused by customers of the premises. Copies of the representations and petition are available.

A representation has also been received from Ward Councillor, Bernadette Mooney. The representation support the concerns expressed by Local Residents. A copy of the representation is available.

#### **Merseyside Police**

Following consultation with Merseyside Police, the applicant has agreed that the following conditions be imposed on the Premises Licence if the application is granted:

- The premises must operate a refusals book which must be available for inspection by an Authorised Officer.
- A 'Challenge 25' Policy must be implemented and notices must be prominently displayed relating to this policy.

- CCTV must be installed at the premises which includes recording facilities which must be retained for seven days and which can be viewed by an Authorised Officer.
- Sales of alcohol must only be made when meal(s) are purchased.
- Proof of age must be requested upon delivery.
- There must be no sale of strong strength alcohol on the premises with an ABV of 7% and above.
- Staff must be fully trained and updated in respect of the Licensing Laws and records of this training must be recorded for inspection by an Authorised Officer.
