1.0 EXECUTIVE SUMMARY

1.1 The purpose of this report is to consider an application for the review of a Premises Licence under the provisions of the Licensing Act 2003.

2.0 RELEVANT BACKGROUND

2.1 Bam Buddha currently has a Premises Licence to allow the following Licensable Activities:

Regulated Entertainment (Recorded Music and Anything of a Similar Description)

Sunday to Friday 10.00am to 4.00am
Saturday 10.00am to 6.00am

Entertainment Facilities (Facilities for Making Music, Dancing and Anything of a Similar Description)

Sunday to Friday 10.00am to 4.00am
Saturday 10.00am to 6.00am

Late Night Refreshment

Sunday to Friday 11.00pm to 4.00am
Saturday 11.00pm to 5.00am

- 2.2 A copy of the Premises Licence setting out the above hours and conditions attached to the licence is available.
- 2.3 The Licensing Act 2003 Sub-Committee may, having regard to the application for review and any relevant representations, take such of the following steps as it considers necessary for the promotion of the licensing objectives:
- Modify the Licence conditions (permanently or for a temporary period of up to 3 months).
 - Exclude a licensable activity from the scope of the Licence (permanently or for a temporary period of up to 3 months).
 - Remove the Designated Premises Supervisor (if applicable).
 - Suspend the Licence for a period not more than 3 months.
 - Revoke the Licence.

The licensing authority may decide that no action is necessary if it finds that the review does not require it to take any steps necessary to promote the licensing objectives.

3.0 APPLICATION

- 3.1 An application has been received from Merseyside Police to review the Premises Licence for the premises known as Bam Buddha, 34 - 42 Conway Street, Birkenhead. Merseyside Police have advised that the grounds for review are in relation to the prevention of crime and disorder.
