1.0 EXECUTIVE SUMMARY

- 1.1 The purpose of this report is to consider an application for the review of a Premises Licence under the provisions of the Licensing Act 2003. The application is made by Merseyside Police and relates to the premises known as **Club Zu, 28 Oliver Street East, Birkenhead.**

Regulated Entertainment (Live Music, Recorded Music, Performance of Dance and Anything of a Similar Description)

Monday to Saturday 12:00 to 04:00
Sunday 12:00 to 02:00

Entertainment Facilities (Facilities for Making Music, Dancing and Anything of a Similar Description)

Monday to Saturday 12:00 to 04:00
Sunday 12:00 to 02:00

Late Night Refreshment

Monday to Saturday 23:00 to 04:00
Sunday 23:00 to 02:00

2.2 The Licensing Act 2003 Sub-Committee may, having regard to the application for review and any relevant representations, take such of the following steps as it considers necessary for the promotion of the licensing objectives:

- Modify the Conditions of the Licence.
- Exclude a licensable activity from the scope of the Licence.
- Remove the Designated Premises Supervisor.
- Suspend the Licence for a period not exceeding three months.
- Revoke the Licence.

The licensing authority may decide that no action is necessary if it finds that the review does not require it to take any steps necessary to promote the licensing objectives.

3.0 APPLICATION

3.1 An application has been received from Merseyside Police to review the Premises Licence for the premises known as Club Zu. The Licensing Sergeant has advised that the grounds for review are in relation to the Prevention of Crime and Disorder and Public Safety due to the Premises Licence Holder illegal abstracting electricity at the premises.

3.2 Further information to support the above grounds for review is included within the application which is available.
