#### Alcohol Free Zone – Birkenhead, Victoria Park-Mersey Park.

I write to request that consideration be given to an Alcohol Free Zone in the area in and Around Victoria Park and Mersey Park.

The Area in question would be bounded by the following roads. Bedford Avenue, Old Chester Road, Sydney Road, Allerton Road, Church Road, and Bebington Road (Please see map at **Appendix A** and a full list of roads that would be effected at **Appendix B**.)

The problem of Anti Social Behaviour in this area has been highlighted for some years and appears to be on the increase. One of the main issues raised is the drinking of alcohol in this area in particular by youths and that the unruly behaviour that follows includes violence, the discarded litter and the utilisation of discarded bottles, etc, as weapons.

The situation is now seriously affecting the quality of life of those that reside in the area. Residents at a public meeting held at the Rock Ferry Library 24th July 2006 raised concerns and the provisdion of an Alcohol Free Zone was discussed. Minutes of the meeting are attached at **Appendix C**.

Current Policing operations in the area continue to target the location and alcohol is seized on regular basis from youths congregating in the area on a nightly basis. Numerous fixed penalties have also been issued to people who are purchasing alcohol for underage drinkers. Operation Cougar is to be reinstated and will target incidents of ASB in this and other areas throughout the Wirral.

A gang culture has been created with in the parks and territories marked. These gangs have been given names that denote their individual territories. Congregations of more than 50 youths are a regular occurrence and the attraction is the wide-open spaces of the parks and hidden areas with in the same.

The local off licences have been targeted in a number of ways. Operation Marton ha been used along with plain clothes patrols in order to target the sales of alcohol to minors with some success, however it does not seem to have halted the consumption of alcohol. Residents report seeing youths, both male and female, walking in the vicinity of the parks on a regular basis openly carrying bottles, cans and cases of beer into the park.

An examples of incidents that the police are called to deal with include the following.

- 2133 hours 02.06.06, 30- males and females all drinking carrying poles looking for trouble.
- 1915 hours 03.06.06, 20-30 youths all having alcohol with them in the park shouting abuse at passers by.
- 1417 hours 07.06.06, report of a 30 year old female found drunk having been there since 0930 hours lying on the grass with a bottle by her side.
- 2035 hours 10.06.06, 40 youths aged 15 gathering in Victoria park all drunk.
- 2040 hours 11.06.06, Youth shot at with a BB gun
- 2101 hours 16.06.06 Report of 10 youths drinking.
- 2114 hours 16.06.06 70-80 youths congregating inside Victoria Park carrying weapons.
- 0243 hours 17.06.06 Drunken youths throwing bottles shouting and swearing.

This is just a snapshot of incidents over a two week period the bulk of which progressed on to other incidents that spill onto the residential areas that are adjacent to the parks.

In addition to these incidents there are numerous incidents of violence including sexual offences. There have been reports of drunken females not being able to remember what has happened to them for several hours questioning if they had been subjected to a sexual assault. If these illegal activities continue to go unchecked then it can only escalate into a more serious incident involving serious violence or worse a fatality.

As you can see from these sample incidents the Anti Social Behaviour of those responsible is seriously affecting the quality of life for those law abiding citizens that reside in the area and it needs to be curtailed. I strongly believe that the provision of an Alcohol Free Zone as described would provide Police with a very useful tool that would be used with discretion for the benefit of those residents as described. It would assist in making the parks a safe place to enjoy and reduce the fear of those that live around and use the parks. It would also go on to support other multi agency initiatives and strategies that are planned for the location.

As the Neighbourhood Inspector for the area concerned it is my wish to make the location safe simultaneously re-establishing a level of reassurance for the community and a sense of security. I wish to make it safe and attractive for all those that use the parks and be able to participate in all activities in the knowledge that it is safe. I cannot emphasise to strongly my desire for a ban on the consumption of alcohol in public places in the area described.

This ban would have the full support of residents in the designated area and also has the full support of all six councillors that represent the area in question. Letters of support from all six are listed at **Appendix D**. I have not yet met one person who would NOT support this application

To legislate in favour of my proposal will continue to provide the police with a very useful and effective tool that would be used with discretion, to the benefit of the many thousands of residents, businesses and visitors to the Birkenhead area. It will be beneficial to good order and would support other multi agency initiatives and strategies and I ask that it be given favourable consideration.



#### Youth disturbances and anti-social behaviour in and around Mersey Park and Victoria Park (Tranmere & Rock Ferry)

Notes of the public meeting held on 24<sup>th</sup> July 2006, at the Community Hall, Rock Ferry Library.

### PLEASE CHECK & CORRECT ROAD NAMES PRIOR TO USE

In attendance: Cllrs Phil Davies (in the chair), Brian Kenny & Jean Stapleton (Birkenhead & Tranmere Ward Cllrs Moira McLaughlin, Chris Meaden & Bill Davies (Rock Ferry Ward)

Representatives from Wirral Council, Merseyside Police, Tranmere Alliance & Together NMP

Around 60 local residents (attendance list record available)

#### 1. Purpose of the meeting

Cllr Phil Davies explained that the meeting had been called in response to a large number of complaints received by ward councillors about problems with youth disturbances and anti-social behaviour.

The meeting would allow residents to tell councillors and representatives from local agencies present about the problems they are experiencing. Hopefully, during at the end of the meeting residents will have had the opportunity to:

- 'Get things off their chest'
- Make suggestions about how the issues causing concern might be resolved
- Agree a list of actions to address these issues
- Be reassured that the problems have been recognised and that appropriate action would be taken.

Cllr Phil Davies advised residents that it was the councillors' intention to respond to the issues by the end of August, with a full report being provided at a follow-up public meeting.

#### 2. Resident Reports, Experiences and Ideas

Residents were invited to report problems they were experienced from young people gathering in the area and to put forward their ideas for resolving these issues. The information gathered from residents was to be used to compile a fuller picture of the problems residents were having and to inform any planned response.

#### Well Lane resident:

There are gangs of youths (male and female), 50-60 strong gathering, mostly on Friday evenings. They hurl bricks, bottle etc, and we have bullet holes in windows.

We have been keeping anti-social behaviour diaries, and have phoned the wardens, and have given 3 addresses in response to the local grafitti initiative...

Youths are being chased between the parks by the police.

Is it beyond the wit of the police to block access?

We are unhappy with the police response and their ability to prevent repeats

#### Graswell Road resident:

Our experience is the same...

The Police have shifted them (gangs of young people) over the last month. Moving them to Mersey Park just relocates the problem.

The (caged) football pitch (in Mersey Park) is being used by youths to 3 am. Young people are having sex in the hut, and there is glass and syringes left in the area.

The park bobbies have gone. The park no longer has railings. Youths have no respect.

Girls (under 18) with litre bottles of Lambrini are blatantly swanning along the roads between the two parks

Three residents have been assaulted by these kids (linked by residents to youths being challenged by local residents because of their behaviour).

These kids feel as though they are untouchable, and local children are intimidated.

#### Whitchley Road resident:

We don't have the same problem. Our problem is with the behaviour of other residents and general anti-social behaviour, fights and drunks

Adults are sitting on walls at 6 am drinking.

The whole area should be alcohol free

Town Road resident:

We have had 15 under-aged drinkers dropping bottles between midnight and 5am with mobiles.

The police were aware but never responded. The young people left only when it started to rain

#### Bamfull Road resident:

Where the police do respond we have 40-50 10 to 14 year olds bwing followed by a police van but not dispersed. Not one of the young people (were recognised as) lived in the immediate area, and they stayed until 1am.

Young people are simply running amok. I thought congregating in large groups and drinking was not allowed.

Anti-social behaviour is so out of control that decent people are now in the minority...they have taken the streets

You can't come out when young people are urinating on your car because of the intimidation

#### Inglemere Road/Old Chester Road resident:

The shop (off-license) sells drink under-age and to others (adults) going in (to purchase alcohol for minors)

Remove their licenses

18 year olds put beer into wheelie bins for the younger ones to collect

#### Inglemere resident:

When I chased two youths sitting on the wall (following incidents when a disabled resident has had their car vandalised) gangs were at either end of the street. They were drinking beer (obtained) from the shop on the corner.

This is going on every Friday and Saturday night. It's (the road is) a thoroughfare between the shop and the park.

Parks should be out of bounds in the evening. There should be a ban on drinking.

Inglemere Road/Old Chester Road resident:

Gangs, mainly girls, are hanging around and drinking

Alleygates in Inglemere/Southgate, locks have been broken and replaced repeatedly. We have had a letter from the Council saying they can't afford any more repairs

Why don't we have signs saying "Residents will not tolerate anti-social behaviour and will act on it"

Wheelie bins left outside alleygates are used to jump the gates in gated areas

People are stashing alcohol in and around the playground in Victoria Park

Put on some activities in the park for yoiung people (mainly in the day time)

Improve lighting in the park

Shouldn't parents be made responsible for what young people get up to?

#### 3. Police Response

Neighbourhood Inspector Mick Blease was invited to respond to the points raised. He advised residents that:

- In the event of problems with the police service being experienced residents should contact him at Well Lane.
- The area is a difficult one to police
- Alcohol seizures (from minors) are high
- There is no law against gatherings unless a (Section 30) dispersal order is put in place
- Disperal of large groups can cause further problems in surrounding areas (starburst effect)

- A recent operation (Cougar) had brought additional (police) officers into the area to tackle under-age drinking and had proved successful
- The police were working with councillors to ban drinking, bottles and glasses in parks
- Residents wishing to report anti-social behaviour can call "It's Your Call" call centre and Crime Stoppers

#### 4. **Resident suggestions:**

- How about setting up mobile CCTV in the area
- Use the money for alleygates where they have not been put up (due to resident objections) to pay for CCTV cameras
- Back Byrne Avenue (Leisure Centre) bids for funding to put on activities for young people
- Youth Service and other agencies should work together to stop this
- Alleygates help solve and end problems, They are 110% successful. Everyone should have them and they stop anti-social behaviour in alleyways

#### 5. Agency response

Cllr Phil Davies summed up the actions suggested and advised residents that councillors would be looking to work with the relevant agencies to implement a response. The actions were:

- a) Alcohol Free Zone
- b) Section 30 Dispersal Order
- c) Anti-Social behaviour Unit working with residents facing antisocial neighbours
- d) Clamping-down on the sale of alcohol to minors (and on behalf of minors)
   Use of mobile CCTV
   Installation of Anti-social behaviour will not be tolerated signs
   Alleygated ungated streets
   Enforcement action against resident and commercial
   dumping/fly-tipping
   Youth Service outreach engagement with young people &
   gangs
- e) Improved lighting in the parks

- f) Increasing the height of fencing and use of lockable gates for caged football pitch
- g) Lobbying for more Police resources for the area
