45. TRIBUTES

The Council stood in silent tribute to the memory of former members - Mr James Waugh (who represented North Bromborough ward on the former Bebington MBC, 1963-67), Mrs Eva Garnett (member of the former Wallasey CBC and Mayoress of Wallasey in 1966/67), Honorary Alderman Frank Theaker (former member and alderman of Bebington Borough Council, councillor for the Bebington Ward on Wirral Borough Council, 1973-84 and Mayor of Wirral in 1980/81) and Mr Michael J Ebbs (councillor for the Liscard Ward, 1973-88 and 1992-96) - and Mr Kenneth ("Monty") Lea (Mayor's Consort, 1996/97).

46. CLAIRE HOUSE

The Mayor introduced Ms Margaret Davies, who spoke about Claire House, the Wirral children's hospice named after Clare Caine, which had opened in 1998 and offered support to 130 terminally ill children and their families. The hospice was

run by dedicated specialist staff, supported by over 100 volunteers, and relied for its funding needs of over £100,000 a month on the proceeds of 13 charity shops and voluntary donations (including the support they received as one of the main beneficiaries in 2001/02 from the Mayor's Charity Fund).

She urged members of the Council to take advantage of regular open days to visit Clare House and see for themselves the facilities provided for the children and their families.

47 **PETITIONS**

(d) Councillor Isabel Moon on behalf of residents of Spital and Bebington concerned about the unacceptable level of graffiti and general untidiness of the area;

(e) Councillor Mrs Wood on behalf of members of the Harrison Park Bowling Club and local residents, calling for the replacement of the Pavilion at Harrison Park, Wallasey;

(f) Councillor Mrs Wood on behalf of residents of the Village Estate, Wallasey Village, concerned about the parking of cars near the narrow estate entrance, and calling for the introduction of parking controls;

(g) Councillor Robert Moon on behalf of residents of Bromborough, objecting to the withdrawal of bus service 202 without consultation or prior notice;

(h) Councillor Reisdorf, on behalf of 191 local residents, calling for improved facilities for the use of skateboards in the Greasby area.

(2) Pending the Government adopting such a view, any charges to tunnel users should not include any amounts to be used for other public transport purposes as this would be equivalent to a new tax on tunnel users which would bear disproportionately on Wirral residents and businesses."

54. CABINET (13/12/01) - MINUTE 455 P 1312 - ENGINEERS DEPARTMENTAL SERVICE PLAN 2001-06 AND BUDGET 2002/03

Moved by Councillor Cummings Seconded by Councillor Robinson

That minute 455 be amended by the deletion of paragraph (2) of the recommendation and the substitution of:-

"(2) This Council notes that in 2001/02 the Labour administration is spending £509,700 less than its Highways SSA of £9,157,000, and further notes that it is Labour's intention to reduce the amount spent on highways maintenance by £500,000 for 2002/03.

(3) The Council is opposed to any reductions within the coast protection/drainage, traffic/traffic signals and highways improvement elements of the highways budget as such reductions could only:-

(a) lead to further public dissatisfaction with the roads and pavements within the Borough;

(b) further add to the £28m needed to bring Wirral's highways and street lighting infrastructure up to a reasonable standard;

(c) further increase the £7.5m that Labour has taken from highways maintenance in real terms since the Labour budget of 1996/97.

(4) Council therefore calls for a report to be prepared, exploring options on ways to redress the balance to bring highways budget expenditure up to the Government's SSA figure."

Following a debate and Councillor Harry Smith having replied, the motion was put and carried (33:32).

55. CABINET (13/12/01) - MINUTE 455 P 1312 - ENGINEERS DEPARTMENTAL SERVICE PLAN 2001-06 AND BUDGET 2002/03

"(2) That, subject to the Council's approval, the saving of £40,000 identified in the Departmental Service Plan in respect of the closure of the Brussels office be approved.

(3) That this Council does not accept the proposed reduction of £35,000 in grants to the voluntary sector without being informed of exactly what the impact would be and whether any particular organisation might suffer as a consequence.

(4) That this Council does not accept the proposed reduction of £35,000 in the budget for Wirral Direct because it believes that it is more appropriate for it to expand its activities in the current economic climate."

(b) approval of the application results in the destruction of the visual amenity of the local Conservation Area by reason of its forward projection from other surrounding properties which would be clearly visible from the beach."
