- 1.1 Sickness statistics

The chart below shows the number of days lost per, full time equivalent, (FTE) member of staff for this first quarter. The chart also shows the absence rates for the same period last year and the corporate target for all departments of 8.9 days.


The Department has focussed considerable resources and time to reduce the number of days lost due to absence. These measures have led to a significant fall in the number of days lost per employee compared to last year. In addition, the trend is continuing downward with the latest absence rates (June – 6.2 days) well below the corporate target of 8.9 days.

2.1 Performance Summary


Of the 66 performance indicators (PIs) that can be reported at this first quarter (see 2.3 for full list of the Department's performance indicators); the chart below shows those that are on target and those that are not on target.

69% are on target (45 Pls) 31% are not on target (21 Pls)



Of the 66 indicators that can be reported at the first quarter, the chart below shows those that have improved, deteriorated, stayed the same or have no comparative data (i.e. the PI did not exist last year) when compared with the same quarter last year.

51% have improved (31 indicators)4% have deteriorated (3 indicators)2% have stayed the same (1 indicator)43% no comparative data (25 indicators)

Agreement has been reached and raining undertaken to allow more officers to input data onto the nonitoring system thus providing a nore complete and accurate picture of domestic violence levels. Wirral has doubled the number of DV dvocates who assist victims and who are able to respond to the noreased levels of domestic violence eporting which is now taking place. We will ensure system is kept under eview during the coming year, given eward element attached to this. During the first quarter of 2007 -08 he level of risk has increased in espect of our target to reduce the number of domestic violence repeat ncidents. The database used to neasure this performance is updated by Police Officers within the Family Crime Investigation Unit. Since the tart of 2007 - 08 only a proportion of the required entries have been nade on the database and a backlog of some 440 cases await entry. Vithout a full data entry the level of epeat victimisation cannot be istablished nor can work to reduce his level be completed.
