ACCEPTANCE OF TENDER – DEMOLITION OF PUBLIC CONVENIENCES AT ATHERTON STREET BIRKENHEAD

1.0 **EXECUTIVE SUMMARY**

1.1 This report informs Committee of the acceptance of a tender for the demolition of public conveniences at Atherton Street, Birkenhead.

2.0 **BACKGROUND**

- 2.1 At Cabinet on 16 June 2005 members resolved that the Atherton Street (Charing Cross) toilets should be demolished to facilitate the construction of a new supermarket and car park as part of Birkenhead Town Centre redevelopment.
- 2.2 Whilst the facilities remained accessible for a short period of time pending progress of the Birkenhead Town Centre Development Plan the premises have steadily deteriorated and were subsequently closed for public safety reasons in 2006 following partial collapse of the internal structure.
- 2.3 More recently the local community, supported by Members in Birkenhead and Tranmere Ward, have called for early demolition of the facilities as a result of concerns regarding anti social behaviour associated with, and in the immediate vicinity of, the vacant building.
- 2.4 The Director of Technical services was therefore asked to seek tenders for the demolition of the facility. Four tenders were received.
- 2.5 Details of the lowest tender received, which has been accepted under delegated powers in accordance with paragraph 14.4 of the contract procedure rules, are as follows:
