

#### 1. MANAGEMENT OF RESOURCES

#### 1.1 Sickness statistics

The chart below shows the cumulative number of days lost per full time equivalent, (FTE) member of staff for up to the end of this second quarter. The chart also shows the absence rates for the same period last year and projected absence for the remainder of this year. (Linear dotted line)

Since April 2007 the Council has started using a new means of calculating absence. Previously, the Authority had used the national Best Value Performance Indicator 12 as the means for measuring absence. The new method now incorporates all temporary and seasonal workers who were not included in the BVPI 12 calculations. It is important to note these differences when making comparisons with other departments or previous years as this department has a disproportionately greater number of seasonal and temporary workers as compared to other departments.



The Department continues to devote considerable resources to reduce the number of days lost to absence. This has led to a significant reduction in the number of days lost per employee. The projected absence line shows that we are on track for a final figure of 11.75 FTE which is below our year end target of 12.75 and a significant reduction on last year's figure of 13.45 days lost.


#### 2. PERFORMANCE

#### 2.1 Performance Summary

#### **On Target?**

The chart below shows performance indicators (PIs) that are over performing, on target, nearly on target and those that are not on target. (See 4.0 for a full list of the Department's performance indicators).


On Target, green, is where the performance indicator is within 5% of the target, amber (or nearly on target) if it is between 5% and 10% of the target and red (not on target) if it is more than 10% under the target figure. If the performance indicator has improved by more than 5% then the indicator will be Blue and it will be identified as 'Over Performing'.



#### **Direction of Travel**

The chart below shows (compared with the same quarter last year) those performance indicators that have improved, deteriorated, stayed the same or have no comparative data (i.e. the PI did not exist last year).

50% have improved (31 indicators)7% have deteriorated (4 indicators)5% have stayed the same (3 indicator)38% no comparative data (23 indicators)



These second quarter figures show that we are continuing to sustain our performance with half of all indicators improving and only 4 performance measures indicating deterioration in performance compared to the same period last year.

#### 2.2 Performance Exceptions

Of the indicators that can be reported at this second quarter, the following PIs were either over or under performing.

#### 3.2 Financial Exceptions

#### 3.2.1 Revenue budget exceptions

The Regeneration department is currently forecasting a budget variation for 2007/08 of £0.87m; this projection is based mainly on the non-implementation of Service Re-Engineering £546,000, a projected under-recovery of income of £60,000 for the Golf Courses resulting from a very wet mid-summer period and the loss of £26,000 of income at Birkenhead Central Library.

The department has identified £0.544m of non-service re-engineering savings in areas such as the capitalisation of HMRI, the deletion of vacant posts and review of staff rotas. Service re-engineering savings of £0.546m have yet to be implemented however savings of £0.507m are in the process of being implemented, which include the maximisation of external funding £79,000, the generation of additional income £140,000 and the reduction of staffing budgets £75,000.

Policy options are currently being implemented: £0.18m free swimming for young people and pensioners; £0.18m for smoke free campaign; £0.1m for the Cultural Services development plan; £0.05m each for youth sports nights and security in parks and cemeteries; and £0.02m for dog fouling enforcement.

There are number of budgets which are regarded as volatile areas of expenditure. These are highlight below:
