 - 3. Any vehicle which is more than 9 years and 6 months old will be issued with a licence that will expire on the day before it reaches 10 years old.
- 3.2 The proprietor of the vehicle, Mr Williams of MW Transport, has applied to license the vehicle as a Private Hire Vehicle.

- 3.1 The current criteria that vehicles must comply with before being granted a Private Hire Vehicle Licence as set out in the Statement of Hackney Carriage and Private Hire Licensing Policy includes the following:
 - The front windscreen must let at least 75% of light through and all other windows must let at least 70% of light through.
- 3.2 The proprietor of the vehicle, Mr Neves, has applied to license the vehicle as a Private Hire Vehicle to undertake work providing an executive travel service.
- 3.3 The date of first registration of the vehicle is 7 February 2023.
- 3.4 Mr Neves has held a Private Hire Driver Licence since 14 March 2019 and his current licence is due to expire on 18 September 2025.
