#### REPORT SUMMARY

The purpose of this report is for the Licensing Act Sub-Committee to consider an application to Review a Premises Licence under the provisions of the Licensing Act 2003. The application is made by Merseyside Police and relates to the premises known as Sue's Bar, 25 Argyle Street, Birkenhead, CH41 6AA.

#### RECOMMENDATION

The Licensing Act Sub-Committee is recommended to Review the Premises Licence in respect of the premises known as Sue's Bar, 25 Argyle Street, Birkenhead, CH41 6AA.

#### SUPPORTING INFORMATION

#### 1.0 REASON FOR RECOMMENDATION

1.1 In accordance with the Licensing Act 2003 it is a statutory requirement for this Sub-Committee to determine the application to Review the Premises Licence.

#### 2.0 OTHER OPTIONS CONSIDERED

2.1 There is no provision for other options to be considered.

#### 3.0 BACKGROUND INFORMATION

3.1 The premises currently have a Premises Licence which permits the following Licensable Activities:

#### 3.2 **APPLICATION**

- 3.3 An application has been received from Merseyside Police to review the Premises Licence for Sue's Bar, 25 Argyle Street, Birkenhead, CH41 6AA. The grounds for the review relate to reports of serious incidents and violent disorder occurring at the premises as well as frequent breaches of the conditions attached to the Premises Licence. Merseyside Police consider that the current operation of these premises undermines the licensing objectives in particular the prevention of crime and disorder, and public safety.
- 3.4 Further information to support the above grounds for the Review will be provided to the Licensing Act Sub-Committee in advance of the hearing.

- 3.5 The Licensing Act Sub-Committee may, having regard to the application for the Review and any relevant representations, take such of the following steps as it considers appropriate for the promotion of the licensing objectives:
  - Modify the Conditions of the Licence.
  - Exclude a licensable activity from the scope of the Licence.
  - Remove the Designated Premises Supervisor.
  - Suspend the Licence for a period not exceeding three months.
  - · Revoke the Licence.

The Licensing Act Sub-Committee may decide that no action is appropriate if it finds that the Review does not require it to take any steps that are appropriate to promote the licensing objectives.

#### 3.6 **REPRESENTATIONS**

#### LICENSING AUTHORITY

A representation has been received from the Licensing Authority who support the application to review the Premises Licence made by Merseyside Police. The representation relates to serious crime and disorder occurring at the premises being caused by customers of the premises. A copy of the representation is available.

#### **ENVIRONMENTAL HEALTH**

A representation has been received from Environmental Health who have advised that they have issued the premises with a Section 80 Environmental Protection Act 1990 Abatement Notice for Statutory Noise Nuisance which is currently in force. A copy of the representation is available.

#### **LOCAL RESIDENT**

A representation has been received from a Local Resident which relates to anti-social behaviour being caused by customers of the premises. A copy of the representation is available.

- 5.1 Section 51 of the Licensing Act 2003 provides that at any stage, following the grant of a Premises Licence or Club Premises Certificate, a Responsible Authority, or any other person, may ask the Licensing Authority to review the licence or certificate because of a matter arising at the premises in connection with any of the following four licensing objectives:
  - The prevention of crime and disorder

- Public safety
- The prevention of public nuisance
- The protection of children from harm

#### 7.0 RELEVANT RISKS
