3.1 The current criteria that vehicles must comply with before being granted a Private Hire Vehicle Licence includes the following:

The front windscreen must let at least 75% of light through and all other windows must let at least 70% of light through.

- 3.2 The proprietor of the vehicle, Mr Farrell, has applied to license the vehicle as a Private Hire Vehicle. Mr Farrell has advised the Licensing Authority that whilst it is possible for the two rear side passenger windows and rear window to be changed to clear glass, it is not possible to replace the rear side quarter windows.
- 3.3 The date of first registration of the vehicle is 28 September 2018.
- 3.4 Mr Farrell is in the process of applying for the grant of a Private Hire Driver Licence.
- 3.5 Should the Licensing Panel determine that the vehicle may be licensed as a Private Hire Vehicle it will be necessary for it to be examined at one of the Council's authorised testing stations in order for it to receive a valid MOT and Compliance certificate.
- 3.6 The vehicle will be available for inspection at the meeting.
