1.0 **EXECUTIVE SUMMARY**

1.1 The purpose of this report is to consider an application for the review of a Premises Licence under the provisions of the Licensing Act 2003.

Regulated Entertainment (Recorded Music)

Monday to Saturday	11:00 to 23:30
Sunday	12:00 to 23:30

- 2.2 A copy of the Premises Licence setting out the above hours and conditions attached to the Licence is available.
- 2.3 The Licensing Act 2003 Sub-Committee may, having regard to the application for review and any relevant representations, take such of the following steps as it considers necessary for the promotion of the licensing objectives:
 - Modify the Conditions of the Licence.
 - Exclude a licensable activity from the scope of the Licence.

- Remove the Designated Premises Supervisor.
- Suspend the Licence for a period not exceeding three months.
- Revoke the Licence.

The licensing authority may decide that no action is necessary if it finds that the review does not require it to take any steps necessary to promote the licensing objectives.

3.0 **APPLICATION**

- 3.1 An application has been received from Merseyside Police to review the Premises Licence for the premises known as Milners. Merseyside Police have advised that the grounds for review are in relation to the prevention of crime and disorder, public safety, prevention of public nuisance and the protection of children from harm following a number of incidents that have occurred inside and outside the premises.
- 3.2 Further information to support the above grounds for review is included within the application which is available.

4.0 **RELEVANT REPRESENTATIONS**

4.1 The following Representations have been received in respect of the above application.

Interested Party – Local Residents

In respect of this application, 14 representations have been received from Local Residents who support the application made by Merseyside Police. The representations relate to anti-social behaviour and public nuisance within the immediate vicinity of the premises. The representations also relates to noise nuisance emanating from the premises. A representation has been received from Ward Councillor Andrew Hodson who has received a number of complaints from his constituents in respect of these premises. Copies of the representations are available.

- 4.2 A representation has also been received from Gosschalks Solicitors on behalf of Enterprise Inns PLC as an interested party. Enterprise Inns PLC is the freehold owner of the premises which is subject of a lease agreement in favour of Marie Earnshaw. A copy of the representation is available.
