- 2.3 The Licensing Act 2003 Sub-Committee may, having regard to the application for review and any relevant representations, take such of the following steps as it considers necessary for the promotion of the licensing objectives:
  - Modify the Conditions of the Licence.
  - Exclude a licensable activity from the scope of the Licence.
  - Remove the Designated Premises Supervisor.
  - Suspend the Licence for a period not exceeding three months.
  - Revoke the Licence.

The licensing authority may decide that no action is necessary if it finds that the review does not require it to take any steps necessary to promote the licensing objectives.

#### 3.0 APPLICATION

- 3.1 An application has been received from Merseyside Police to review the Premises Licence for the premises known as Slices.
- 3.2 This application was submitted by Merseyside Police when the premises were known as Déjà Vu. At this time the Premises Licence Holder was Purdeep Chahal who was also the Designated Premises Supervisor. Subsequent to this application being lodged the Premises Licence has been transferred into the name of Mark Taylor and Karen Hamill is now the Designated Premises Supervisor.
- 3.3 Merseyside Police have advised that the grounds for review are in relation to the prevention of crime and disorder, public safety, prevention of public nuisance and the protection of children from harm following a number of serious incidents that have occurred inside the premises. The grounds for review also relates to a number of breaches of the Premises Licence conditions.

- 3.4 Further information to support the above grounds for review is included within the application which is available.
