1.0 EXECUTIVE SUMMARY

Monday to Sunday 10:00 to 00:30

2.2 The Licensing Act 2003 Sub-Committee may, having regard to the application for review and any relevant representations, take such of the following steps as it considers necessary for the promotion of the licensing objectives:

- Modify the Conditions of the Licence.
- Exclude a licensable activity from the scope of the Licence.
- Remove the Designated Premises Supervisor.
- Suspend the Licence for a period not exceeding three months.
- Revoke the Licence.

The licensing authority may decide that no action is necessary if it finds that the review does not require it to take any steps necessary to promote the licensing objectives.

3.1 An application has been received from Merseyside Police to review the Premises Licence for the premises known as Liberty. The Licensing Sergeant has advised that the grounds for review are in relation to the Prevention of Crime and Disorder and Public Safety due to unlicensed activities at the premises which resulted in a serious assault taking place.

3.2 Further information to support the above grounds for review is included within the application which is available.

3.3 A written response to the application has been received from the Premises Licence Holder Mr Christian Saverimutto. A copy of this response is available.

The representations state that there is no concern by these individuals regarding the management of the premises or that the Licensing Objectives are being undermined.

The Licensing Sergeant has also advised that Mr Mitchell has previously been arrested on two other occasions for assault at these premises.
