1.0 EXECUTIVE SUMMARY

1.1 The purpose of this report is to consider an application for a Premises Licence under the provisions of the Licensing Act 2003. The application is made by **Gurdev Singh Bhullar** and relates to the premises known as **Bhullar's Off Licence**, **72 Town Meadow Lane**, **Moreton**.

2.0 BACKGROUND AND KEY ISSUES

- 2.1 These premises have not previously been licensed.
- 2.2 Gurdev Singh Bhullar currently holds a Premises Licence at a premises located at 82-84 Town Meadow Lane, Moreton. These premises are due to be demolised.
- 2.3 On 22 February 2012, Members of the Licensing Act 2003 Sub-Committee considered an application made by Merseyside Police to review a Premises Licence at 82-24 Town Meadow Lane, Moreton following the sale of alcohol to an underage person which took place at the premises and illicit alcohol and tobacco found at the premises. Members resolved to impose a number of conditions to the Premises Licence. A copy of the decision of the Licensing Act 2003 Sub-Committee is available.
