1.0 EXECUTIVE SUMMARY

- 1.1 The purpose of this report is to consider an application for the review of a Premises Licence under the provisions of the Licensing Act 2003. The application is made by Merseyside Police and relates to the premises known as **K and G News and Wine, 338 Old Chester Road, Rock Ferry.**

2.0 BACKGROUND AND KEY ISSUES

- 2.1 K and G News and Wine currently has a Premises Licence, to allow the following Licensable Activity:

Sale by Retail of Alcohol

Sunday to Saturday 08:00 to 23:00

Hours Open to the Public

Sunday to Saturday 08:00 to 23:00

- 2.2 The Licensing Act 2003 Sub-Committee may, having regard to the application for review and any relevant representations, take such of the following steps as it considers appropriate for the promotion of the licensing objectives:

- Modify the Conditions of the Licence.
- Exclude a licensable activity from the scope of the Licence.
- Remove the Designated Premises Supervisor.
- Suspend the Licence for a period not exceeding three months.
- Revoke the Licence.

The licensing authority may decide that no action is appropriate if it finds that the review does not require it to take any steps that are appropriate to promote the licensing objectives.

3.0 APPLICATION

- 3.1 An application has been received from Merseyside Police to review the Premises Licence for the premises known as K and G News and Wine. Merseyside Police have advised that the grounds for review are in relation to the Prevention of

Crime and Disorder due to illegal immigrants being found working at the premises.

3.2 Further information to support the above grounds for review is included within the application which is available.

3.3 Since the application to Review the Premises Licence was made by Merseyside Police, two separate applications have been made to Transfer the Premises Licence and to change the Designated Premises Supervisor. Following no objections from Merseyside Police, these applications have been granted.

3.4 Merseyside Police have made a submission to the Licensing Authority that due to changes that have taken place at the Premises they do not consider it is appropriate to take any further action to address their concerns in respect of the Premises Licence.

3.5 Following the submission made by Merseyside Police both the Premises Licence Holder and Merseyside Police are content for the application for the Review to be heard in their absence.
