#### 1.0 EXECUTIVE SUMMARY

1.1 The purpose of this report is to consider an application for a Premises Licence under the provisions of the Licensing Act 2003. The application is made by Sainsbury's Supermarkets Limited and relates to the premises known as Sainsbury's, Greasby Road, Greasby.

The representations relate to concerns that if this application is granted anti-social behaviour and public nuisance will increase within the vicinity of the premises due to the availability of alcohol and the premises being open 24 hours a day.

Representations have also been received from Ward Councillors Tony Cox and Wendy Clements who have also submitted a petition which has been signed by 133 local residents and supports the individual representations received from local residents.

A representation has also been received from Mr Chris Blakeley, on behalf of Esther McVey, MP who has been contacted by her constituents who have concerns that if the application is granted this will add to the levels of anti-social behaviour which they consider is a current problem within the area.
