1.0 EXECUTIVE SUMMARY

1.1 The purpose of this report is to consider an application for a Premises Licence under the provisions of the Licensing Act 2003. The application is made by **Northern Frontier Pub Rescue and Management Company Limited** and relates to the premises known as **Moreton Sports and Social Club, Pasture Road, Moreton**.

2.0 BACKGROUND AND KEY ISSUES

2.1 These premises previously had a Club Premises Certificate which was held by Moreton Royal British Legion and had the following hours:

Supply of Alcohol

Sunday to Thursday 12:00 to 23:00 Friday and Saturday 12:00 to 00:00

Hours Open to Members and Guests

Sunday to Saturday 12:00 to 00:00

Regulated Entertainment (Live Music and Recorded Music)

Sunday	19:00 to 23:30
Tuesday	12:00 to 16:00
Friday	19:30 to 00:00
Saturday	19:00 to 00:00

- 2.2 On 17 May 2013, a notice of the withdrawal of the Club Premises Certificate was issued to these premises following a Statement that had been received from Merseyside Police advising the Licensing Authority that the Club no longer satisfied the conditions for being a 'qualifying club' in relation to a qualifying club activity to which the certificate relates, namely:
 - The Club was no longer established and conducted in good faith as a club
 - Alcohol was no longer being supplied or intended to be supplied to members on the premises otherwise than by or on behalf of the club.

3.1 The application for the grant of a new Premises Licence is as follows:

- 3.2 Members are advised that in accordance with The Live Music Act 2012, Live Music is no longer considered as the provision of regulated entertainment at a premises open for the supply of alcohol if it takes place between 08:00 and 23:00, the Live Music is unamplified or the Live Music is amplified and takes place in present of an audience of no more than 200 persons.
- 3.3 Following consultation with Merseyside Police, the applicant agreed to amend the application, as detailed within 3.1 of this report, reducing the hours originally applied for.

 - A challenge 25 Policy must be in place at these premises and posters must be displayed relating to this policy.
 - The premises must maintain a refusal log with regular checks. This log must be made available to an Authorised Officer on request.
 - CCTV must be installed at the premises in accordance with the specification issued by the Licensing Authority.
