#### 1.0 EXECUTIVE SUMMARY

- 4.1 Applicants are required to submit as part of their application an operating schedule that sets out how they will conduct/manage their business in accordance with the four Licensing Objectives. A copy of the full application is available.
- 4.2 Members of the Licensing Act 2003 Sub-Committee are advised that the proposals set out in the operating schedule may become conditions of licence should the licence be granted.

- 5.3 Following representations from Merseyside Police (Licensing Division) the applicant has agreed to the following conditions being imposed on the Premises Licence if the application is granted:
  - CCTV must be installed at the premises at least in accordance with the specification issued by the Licensing Authority.
  - There must be a minimum of four Door Supervisors employed at the premises from 22:00 until the premises closes.
  - A drug safe must be installed at the premises.
- 5.4 As the applicant has agreed to the above conditions, Merseyside Police have withdrawn their representation.
