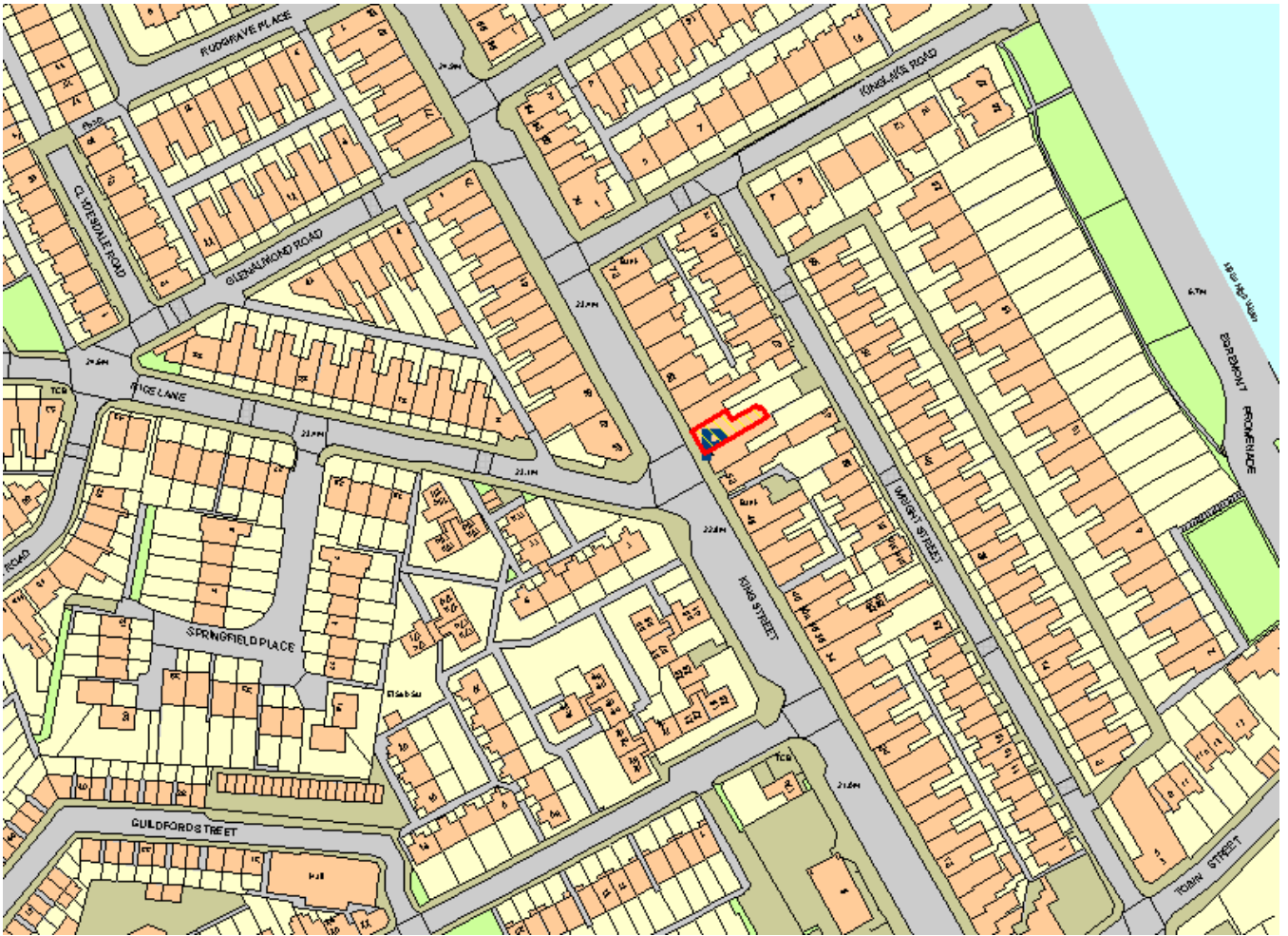

Local Residents

Representations have been received from seven local residents. A petition has also been received signed by 268 local residents. The representations and petition relate to concerns that anti-social behaviour will increase within the vicinity of the premises if this application is granted. Representations also express concerns regarding young persons under the age of 18 gaining access to alcohol. Copies of the representations and petition are available.

Wirral Licensing Authority

A representation has been received from the Licensing Authority. The Licensing Authority has advised that the crime and disorder objective has been undermined by the applicant at another premises where he is currently the Licence holder and Designated Premises Supervisor. The Licensing Authority have evidence that the premises has been selling alcohol outside the hours permitted on the Premises Licence on a number of occasions. The Licensing Authority has concerns that if a Licence is granted to the applicant at these premises then this may result in further breaches being committed and the Licensing Objectives will be undermined. A copy of the representation is available.

Merseyside Police

A representation has been received from Merseyside Police. The representation from Merseyside Police relates to a current problem with street drinkers within the vicinity of the premises. Merseyside Police have concerns that the Licensing Objectives will not be upheld if the application is granted. A copy of the representation is available.

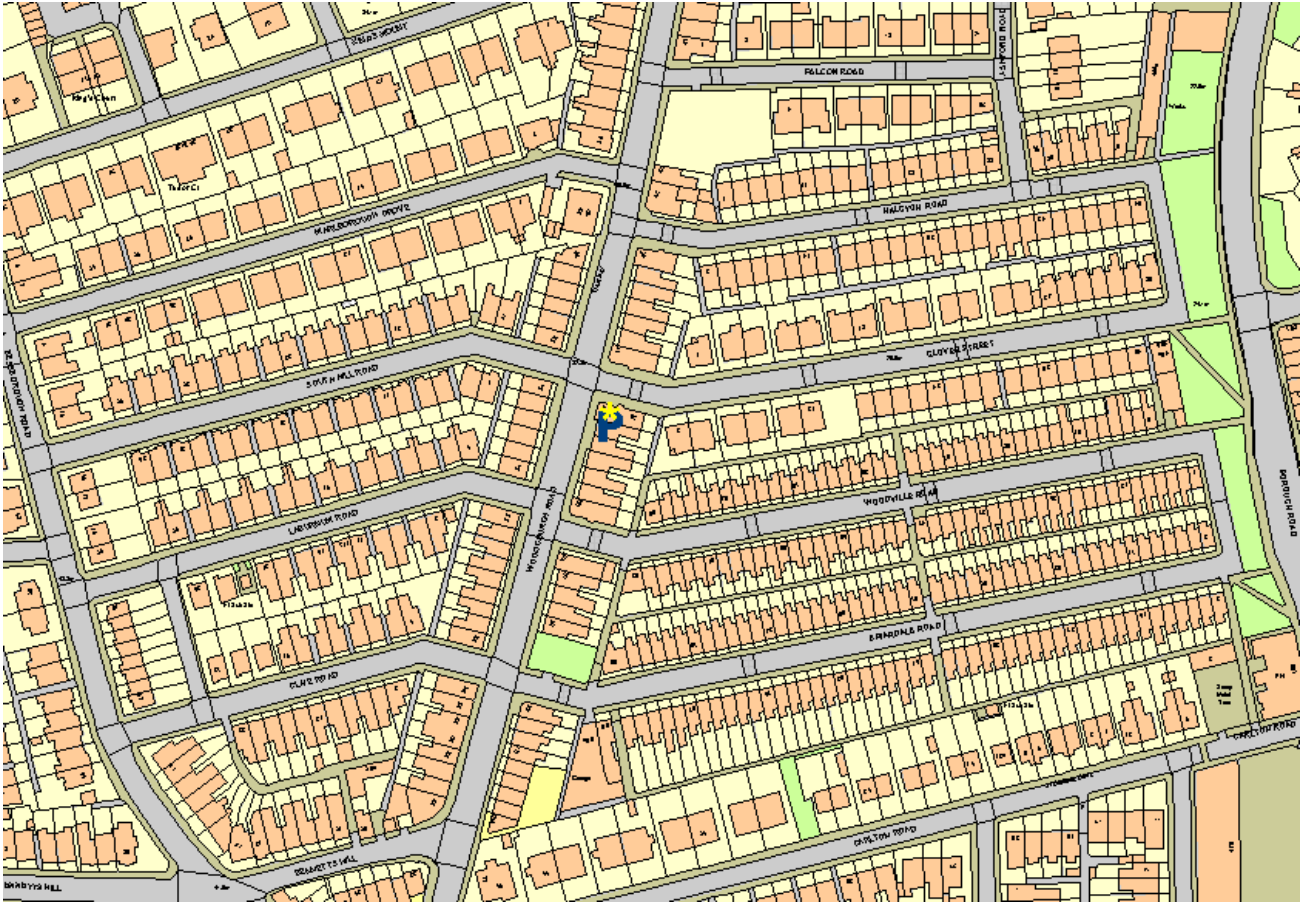
