1.0 EXECUTIVE SUMMARY

1.1 The purpose of this report is for Members to undertake the random selection process for the allocation of the four available Hackney Carriage Vehicle Licences.

2.0 BACKGROUND AND KEY ISSUES

- 2.1 At a meeting of the Licensing Health and Safety and General Purposes Committee on 23 January 2012 Members resolved to impose a limit of 289 on the number of Hackney Carriage Proprietor Licences issued.
- 2.2 Following a period of public consultation Members of the Licensing Health and Safety and General Purposes Committee resolved at their meeting on 25 September 2012 that a random selection process be approved for the allocation of available licences. The adopted procedure is attached at Appendix 1.
- 2.3 Members also resolved that the random selection process will be made using a computer programme at appropriate future meetings of the Licensing Panel.
- 2.4 The availability of four Hackney Carriage Proprietor Licences was advertised and letters sent to all Hackney Carriage and Private Hire drivers, vehicle proprietors and operators, as required in the adopted procedure. The closing date for applications was 30 April 2014.
- 2.5 Twenty three applications have been received. In accordance with the procedure approved by the Licensing Health and Safety and General Purposes Committee a Random Selection Process must now take place to choose four applications from the twenty three. Each application has been allocated a number between 1 and 23.
- 2.6 Members are asked to run the computer programme which will randomly select four numbers between 1 and 23. The applications that have been allocated those four numbers will be the successful applications. Applicants have been advised that the random selection process will take place at the meeting and may attend. Applicants who are successful through this selection process will be contacted and will be required to present a vehicle which complies with the criteria for the granting of a Hackney Carriage Vehicle Licence, within 28 days.

2.7 If any applicant is unable to present a vehicle within the 28 days, a further random selection process will take place at a future Licensing Panel meeting for the remaining applications. This process will be repeated until four licences have been issued.

- The Council notifies the following in writing within one month of the licence becoming available:


Hackney Carriage Proprietor Licence Holders Private Hire Vehicle Licence Holders Hackney Carriage Driver Licence Holders Private Hire Drivers Licence Holders Private Hire Operators

- A Notice is placed on the Council Website and an advert is placed in a local newspaper within one month of the licence becoming available.
- The notice invites applications for Hackney Carriage Proprietor Licence(s) to be received within a closing date of 28 days from when the notice appears in the local newspaper.
- Applications received that meet the criteria for Licensing a Hackney Carriage Vehicle are included in the random selection to be made at a meeting of the Licensing Panel following the closing date for applications.
- The successful applicant(s) is informed and given 28 days to present a vehicle for licensing that meets the criteria for licensing a Hackney Carriage Vehicle at the time the application is made.

Outcome:

- 1) Vehicle licensed
- 2) If no vehicle is presented within the prescribed time or the applicant does not want to progress the application a further selection will take place from the remaining applicants. This process will continue until the licence is issued.

- 2.1 On 22 May 2013 Members of the Licensing Health and Safety and General Purposes Committee resolved that:
 - The maximum age for a vehicle to be licensed as a private hire vehicle be ten years from the date of first registration or manufacture, whichever is the earlier and that this Policy is to have immediate effect.
 - The Licensing Panel be delegated with the authority to act outside this policy.
- 2.2 Private hire vehicle licences are issued on a twelve monthly basis, however once a vehicle reaches six years old, six monthly licences are issued until the vehicle reaches ten years old.

3.0 APPLICATION

- 3.1 The proprietor of the vehicle, Mr Keeley has applied to re-license his vehicle for a further six months.
- 3.2 The vehicle has been licensed as a private hire vehicle since 11 November 2002 and the current licence expires on 14 May 2014.
- 3.3 The date of first registration of this vehicle is 11 November 2002.

1.0 EXECUTIVE SUMMARY

1.1 The purpose of this report is to consider an application to license a Vauxhall Vivaro as a private hire vehicle to carry eight passengers, two passengers being carried in the front.

2.0 BACKGROUND AND KEY ISSUES

- 2.1 The vehicle, registration number FN57 WVZ is currently licensed to carry seven passengers, one being carried in the front.
- 2.2 Council policy, which is reflected in the Private Hire Vehicle Licence Conditions, allows non-standard vehicles (ie MPV's, people carriers) to be licensed as private hire vehicles subject to the standard Private Hire Vehicle Licence Conditions and the following additional conditions:-
 - (1) There must only be the number of passengers seats fitted in the vehicle for which the vehicle is licensed.
 - (2) Two fire extinguishers must be kept in the vehicle, one to be in the front and the other in the rear.
 - (3) Vehicles to be fitted (in addition to the front drivers and passengers doors) with at least two side/rear opening doors and all doors must be easily accessible to all passengers and capable of being opened from inside.
 - (4) A step (which must be approved by the Council) must be available for use at all times.
 - (5) A sign on the rear of the seats in the vehicle must be displayed indicating there is a step available for use and indicating exit doors.
 - (6) Seat belts shall be provided for every passengers the vehicle is licensed by this Council to carry.

- 2.3 The standard private hire vehicle conditions specify that the proprietor shall only allow one person to be carried in the front of the vehicle apart from the driver.
- 2.4 Members have previously considered applications to license a Volkswagen Caravelle, a Volkswagen Transporter, a Ford Tourneo and a Renault Trafic to carry two front seat passengers. These applications were granted by the Licensing Health and Safety and General Purposes Committee.
- 2.5 Members have also previously considered applications to license a Mercedes Vito to carry two front seat passengers. These applications were refused.
- 2.6 In determining previous applications Members considered the following:
 - Whether there was sufficient space for two adult passengers to sit comfortably and safely in the front of the vehicle
 - Access to passenger seatbelts
 - Whether passengers could exit the vehicle safely in an emergency
 - The position of the gearstick/handbrake, and the effect this would have on the comfort of the middle passenger.
- 2.7 The vehicle will be available for inspection at the meeting.
