#### 1.0 EXECUTIVE SUMMARY

1.1 The purpose of this report is to consider an application for the review of a Premises Licence under the provisions of the Licensing Act 2003. The application is made by Merseyside Police and relates to the premises known as **Best One**, **91-93 Brighton Street**, **Wallasey**.

  - Modify the Conditions of the Licence.
  - Exclude a licensable activity from the scope of the Licence.
  - Remove the Designated Premises Supervisor.
  - Suspend the Licence for a period not exceeding three months.
  - Revoke the Licence.

The licensing authority may decide that no action is appropriate if it finds that the review does not require it to take any steps that are appropriate to promote the licensing objectives.

- 3.1 An application has been received from Merseyside Police to review the Premises Licence for the premises known as Best One. The Licensing Sergeant has advised that the grounds for review are in relation to the Premises being linked to criminal activity, namely illegal immigrants being employed at the premises.
