1.0 EXECUTIVE SUMMARY

1.1 The purpose of this report is to consider an application for the review of a Premises Licence under the provisions of the Licensing Act 2003. The application is made by a Local Resident and relates to the premises known as the **Old Tavern Club**, **Magazine Lane**, **New Brighton**.

2.0 BACKGROUND AND KEY ISSUES

2.1 These premises currently have a Premises Licence with the following Licensable Activities:

Sale by Retail of Alcohol

Friday and Saturday 20:00 to 02:00

Recorded Music, Live Music and Performance of Dance

Sunday to Saturday 20:00 to 02:00

- 2.2 The Licensing Act 2003 Sub-Committee may, having regard to the application for review and any relevant representations, take such of the following steps as it considers appropriate for the promotion of the licensing objectives:
 - Modify the Conditions of the Licence.
 - Exclude a licensable activity from the scope of the Licence.
 - Remove the Designated Premises Supervisor.
 - Suspend the Licence for a period not exceeding three months.
 - Revoke the Licence.

The licensing authority may decide that no action is appropriate if it finds that the review does not require it to take any steps that are appropriate to promote the licensing objectives.

3.0 APPLICATION

- 3.1 An application has been received from a Local Resident to review the Premises Licence for the premises known as the Old Tavern Club. The grounds for review are that the premises are linked to illegal activities, public nuisance is being caused to local residents and that disorder is occurring on a regular basis.
- 3.2 In response to the application, the Premises Licence Holder has submitted a Neighbourhood Charter and Dispersal Policy together with a statement on his position in relation to the application. A copy of these documents are available.

4.0 RELEVANT REPRESENTATION

Local Residents

In respect of this application, 14 representations have been received from local residents. A petition containing 108 signatures has also been received. The representations and petition support the application to Review the Premises Licence. Copies of the representations are available.

A representation has been received from Merseyside Police which provides 16 Police reports since January 2013 where it has been alleged that the Licensing Objectives have been undermined. A copy of the representation is available.

Wirral Licensing Authority

A representation has been received from the Licensing Authority which supports the application to Review the Premises Licence due to a number of complaints received from residents who live within the vicinity of the premises. A copy of the representation is available.

Environmental Health (Pollution Control)

Environmental Health (Pollution Control) have provided information for Members of the Sub-Committee on the number of complaints received from local residents within the last three years. This information is available.

Non-Standard Timings:

All of the above activities has been requested to be extended until 02:00 on all Public Holidays.

- 3.2 Members should note that following discussions with Merseyside Police, the applicant agreed to reduce the originally requested terminal hour by 30minutes and also agreed for the following conditions to apply to the Premises Licence if this application is granted:
 - There must be a minimum of one SIA registered door person on duty from 22:00 until the premises is closed to the public on Friday and Saturday nights.
 - There must be no admission to the premises after 00:00.

4.0 PROMOTION OF LICENSING OBJECTIVES

- 4.1 Applicants are required to submit as part of their application an operating schedule that sets out how they will conduct/manage their business in accordance with the four Licensing Objectives. A copy of the full application is available.
