1.0 EXECUTIVE SUMMARY

- 3.2 Following discussions with Merseyside Police, the applicant has agreed to amend the application to include the following conditions in the Operating Schedule:

- All staff must be vigilant and monitor the area immediately outside the premises to ensure that youths do not congregate. Staff must report incidents to the Police if deemed appropriate.

- All staff must ensure that anyone who appears to be under the age of 25, attempting to purchase alcohol, must be asked for proof of age by producing an acceptable form of ID such as a Passport, Photo Driving Licence, Military ID and PASS accredited proof of age card.
- The premises must maintain a refusals book at the premises.
- All staff must receive training in underage sales, refusing to serve alcohol to drunks, proxy sales, conflict management and the Licensing Objectives. All training must be recorded and made available to an Authorised Officer on request.

4.0 PROMOTION OF LICENSING OBJECTIVES

- 4.1 Applicants are required to submit as part of their application an operating schedule that sets out how they will conduct/manage their business in accordance with the four Licensing Objectives. A copy of the full application is available.
- 4.2 Members of the Licensing Act 2003 Sub-Committee are advised that the proposals set out in the operating schedule may become conditions of licence should the application be granted.

3.2 Following discussions with Merseyside Police, the applicant has agreed to amend the application to include the following conditions in the Operating Schedule:

- A Challenge 25 Policy must be implemented. Posters must be displayed relating to this Policy.
- All staff must receive training in underage sales, refusing to serve alcohol to drunks, drug awareness, conflict management and the Challenge 25 Policy. All training must be recorded and made available to an Authorised Officer on request.
- A minimum of two Door Supervisors must be on duty from 22:00 on Friday and Saturday nights.
- Staff must conduct regular checks of the interior of the premises.
- Staff must ensure that any queues or persons gathering outside the premises are managed appropriately.
- All drinking vessels must be made of toughened glass.

3.3 Merseyside Police have advised that they have no objection to the removal of the following proposed condition in the Operating Schedule if the above additional conditions were implemented:

- All staff to obtain a BIIAB Level 2 Award for Personal Licence Holders.
