1.0 EXECUTIVE SUMMARY

- An additional two CCTV cameras must be installed within the Gallery area of the premises.
- An incident booked must be maintained at the premises.
- The premises must promote the use of taxis that provide a call back facility.
- Notices must be displayed asking customers to leave the premises guietly.
- 3.3 A letter has been sent to local residents by the applicant which provides further information in relation to the Premises Licence Application. A copy of this letter is available.
