1.0 EXECUTIVE SUMMARY

1.1 The purpose of this report is to consider an application for a Premises Licence under the provisions of the Licensing Act 2003. The application is made by **Tea Hospitality Limited** and relates to the premises known as **Thyme**, **35-37 Eastham Village Road**, **Eastham**.

2.0 BACKGROUND AND KEY ISSUES

2.1 These premises do not have a Premises Licence and are not currently trading.

3.0 APPLICATION

3.1 The application for a Premises Licence is as follows:

Sale by Retail of Alcohol

Sunday to Saturday	11:00 to 23:00
Christmas Eve	11:00 to 01:00
New Years Eve	11:00 to 01:00

The applicant has indicated that the sale of alcohol will be for consumption on and off the premises.

Hours Open to the Public

Sunday to Saturday	09:00 to 00:00
Christmas Eve	11:00 to 02:00
New Years Eve	11:00 to 02:00

Recorded Music

Sunday to Saturday 10:00 to 23:00

- 3.2 Following discussions with Merseyside Police, the applicant has agreed to the following conditions to be included on the Premises Licence if the application is granted:
 - Alcohol must only be sold or supplied as an ancillary to the provision of substantial table meals and to those persons who are waiting to be seated or those who have finished their meal
 - Any entertainment provided will be background music only
 - The last orders for food must be taken no later than 22:00
 - CCTV must be provided in the form of a recordable system capable of providing pictures of evidential quality and in all lighting conditions particularly facial recognition. Cameras shall encompass all access to and egress from the premises and all areas where the sale/supply of alcohol occurs. Equipment shall be maintained in good working order and correctly timed and dated. Recordings will be available for a period of 31 days and handed to Police on request. The recording equipment being of a digital hard drive system shall be kept in a secure environment under the control of the Premises Licence Holder or other responsible named individual
 - Customers must not take alcoholic drinks outside the premises for consumption within the immediate vicinity of the curtilage of the building
 - The Premises Licence Holder must take all reasonable steps to prevent annoyance or nuisance by persons leaving the premises and shall provide suitable notices at each egress point. Such notices shall be protected from damage or deterioration
- 3.3 Following discussions with Trading Standards, the applicant has also agreed for the following conditions to be included on the Premises Licence if the application is granted:
 - All staff must receive British Institute of Innkeeping Awarding Body training, Fair Trading Award 'Do You Pass' training or equivalent training in relation to Age Restricted Sales.
 - All staff must receive refresher training in relation to age restricted sales every 6 months.
 - Training records must be kept in the premise and made available for inspection upon request.
 - A Challenge 25 Policy should be implemented and maintained. (Including displaying posters and relevant signage).
 - A Refusals Register must be kept and maintained and made available for inspection upon request
