1.0 EXECUTIVE SUMMARY

1.1 The purpose of this report is to consider an application for the review of a Premises Licence under the provisions of the Licensing Act 2003. The application is made by Trading Standards and relates to the premises known as The Offy, 235 Seabank Road, New Brighton.

2.0 BACKGROUND AND KEY ISSUES

2.1 These premises currently have a Premises Licence with the following Licensable Activity:

Sale by Retail of Alcohol

Monday to Saturday 08:00 to 23:00
Sunday 10:00 to 22:30

Non-Standard Timings

Christmas Day 12:00 to 15:00 & 19:00 to 22:30
Good Friday 08:00 to 22:30

2.2 Subsequent to receiving the application to review the Premises Licence from Trading Standards, the Licensing Authority have received an application to Transfer the Premises Licence from Tarsem Singh into the name of Nisha Kaur. Following no objections from Merseyside Police, Nisha Kaur is now the Premises Licence Holder.

2.3 The Licensing Act 2003 Sub-Committee may, having regard to the application for review and any relevant representations, take such of the following steps as it considers appropriate for the promotion of the licensing objectives:

- Modify the Conditions of the Licence.
- Exclude a licensable activity from the scope of the Licence.
- Remove the Designated Premises Supervisor.

- Suspend the Licence for a period not exceeding three months.
- Revoke the Licence.

The licensing authority may decide that no action is appropriate if it finds that the review does not require it to take any steps that are appropriate to promote the licensing objectives.

3.0 APPLICATION

- 3.1 An application has been received from Trading Standards to review the Premises Licence for the premises known as The Offy. The grounds for review are in relation to illegal activity occurring at the premises including the sale of illegal alcohol.
- 3.2 Further information to support the above grounds for review is included within the application which is available.

4.0 RELEVANT REPRESENTATION

- 4.1 The following representations have been received in respect of the above application.

Wirral Licensing Authority

A representation has been received from Wirral Licensing Authority who support the application made by Trading Standards. Following recent inspections at the premises by Licensing Enforcement Officers, a number of breaches of the Premises Licence were identified. The premises were also selling alcohol at a time when the Premises Licence was suspended due to the non-payment of their Annual Fee. A copy of the representation is available.

Environmental Health

A representation has been received from Environmental Health in support of the application made by Trading Standards. The representation relates to the premises not complying with Environmental Health related legislation and concerns that the Licensing Objectives are not being upheld due to the fact that the premises have demonstrated a disregard to the law. A copy of the representation is available.

Public Health

A representation has been received from Public Health who are in support of the application made by Trading Standards who consider that all four licensing objectives are being undermined by the Premises Licence Holder. A copy of the representation is available.
