#### REPORT SUMMARY

The purpose of this report is to consider an application for the review of a Premises Licence under the provisions of the Licensing Act 2003. The application is made by Merseyside Police and relates to the premises known as Al Capones, 70 Argyle Street, Birkenhead.

1.1 It is a statutory requirement for this Committee to determine the application.

3.1 These premises currently have a Premises Licence with the following Licensable Activity:

#### **Late Night Refreshment**

Monday to Thursday 23:00 to 02:30 Friday and Saturday 23:00 to 03:30 Sunday 23:00 to 01:30

#### **Hours Open to the Public**

Monday to Thursday 17:00 to 02:30 Friday and Saturday 17:00 to 03:30 Sunday 17:00 to 01:30

- 3.2 The Licensing Act 2003 Sub-Committee may, having regard to the application for review and any relevant representations, take such of the following steps as it considers appropriate for the promotion of the licensing objectives:
  - Modify the Conditions of the Licence.
  - Exclude a licensable activity from the scope of the Licence.
  - Remove the Designated Premises Supervisor.
  - Suspend the Licence for a period not exceeding three months.
  - Revoke the Licence.

The licensing authority may decide that no action is appropriate if it finds that the review does not require it to take any steps that are appropriate to promote the licensing objectives.

#### 3.3 APPLICATION

An application has been received from Merseyside Police to review the Premises Licence for the premises known as Al Capones. The grounds for review are in relation to serious criminal offences that have taken place at the premises and in the course of the business.

#### 3.4 RELEVANT REPRESENTATION

3.5 The following representation has been received in respect of the above application.

#### Wirral Licensing Authority

A representation has been received from Wirral Licensing Authority who are in support of the application made by Merseyside Police. Following recent inspections at the premises by Licensing Enforcement Officers, a number of breaches of the Premises Licence were identified. The premises were trading at a time when the Premises Licence was suspended due to the non-payment of their Annual Fee. A copy of the representation is available.
