MINUTE EXTRACT

CABINET 25 APRIL 2016

136 FREEDOM OF THE BOROUGH

Councillor Phil Davies introduced a report that recommended that PC David Phillips be posthumously admitted as an Honorary Freeman of the Borough.

The report informed that PC David Phillips had been employed by Merseyside Police from 24 July 2006 until his untimely death last year. The Cabinet noted his posting history set out in the report and that he had been described as follows:

“David was a kind, polite and very caring. He was very proud of being a police officer and carried out his job with bravery and professionalism. David always did everything to the best of his ability. He never accepted second best. He was very sociable, with a great sense of humour. His priorities in life were his family. He was a devoted Family man – perfect husband to Jennifer, wonderful father to Abigail and Sophie and a fantastic son to Carol and Robin. The family could not be more proud of him. They will dearly miss him and he will always be in their hearts.”

Councillor Phil Davies spoke on behalf of all of his Cabinet colleagues recollecting how shocked everyone had been last October when PC David Phillips had been killed whilst carrying out his police duties in Wallasey. Councillor Davies informed that the whole community had been brought together in grief and in a show of solidarity to the Phillips family. Huge numbers of people had queued at Wallasey and Birkenhead Town Halls to express their grief by writing down their thoughts and signing the Books of Condolence that had been opened in memory of PC Phillips. This had been testimony to how people had felt about this appalling tragedy. Councillor Davies informed that the Police existed to keep us safe on a daily basis and PC Phillips’ tragic death had brought it home to us all that the Police do carry out an incredible job.

The Cabinet was apprised that bestowing Honorary Freeman status (posthumously) on PC David Phillips was the highest award that the Council was able to confer and was a very significant step as such an award had only ever been made when someone had made an exceptional contribution to the Borough. Councillor Phil Davies informed that he and his Cabinet colleagues appreciated the work the Police Officer had carried out and indeed the work of all Police Officers and made reference to their courage and bravery.

Councillor Phil Davies reported that, following consultations with the Phillips family and Merseyside Police, it was proposed to hold an Extra-Ordinary meeting of the Council at 6pm on Friday, 20 May 2016 to confer the honour on PC David Phillips. Members of the Council would have the opportunity to pay tribute to PC Phillips at this meeting. It was also intended to hold a small reception afterwards at Wallasey Town Hall for PC Phillips’ family, friends, colleagues and some invited guests. Councillor Phil Davies and his Cabinet colleagues were of the view that this was the right thing to do as a Council and also as a Borough.

Councillor Ann McLachlan concurred with what Councillor Phil Davies had said and informed that PC David Phillips' name would be added to the Freedom of the Borough plaque that hangs in the foyer of Wallasey Town Hall and lists the names of all the Honorary Freemen of the Borough of Wirral. She informed that, sadly, the Extra-Ordinary Council meeting on 20 May 2016 was expected to be one of the most poignant that Members would ever attend.

RESOLVED: That the Cabinet recommends to the Council that

- (1) In pursuance of the provisions of Section 249(5) of the Local Government Act 1972 and in recognition of his dedicated service and bravery during his 10 years of employment with Merseyside Police, PC David Phillips be posthumously admitted as an Honorary Freeman of this Borough at an Extra-Ordinary Council meeting to be held at 6pm on Friday, 20 May 2016; and
- (2) Officers be requested to take all of the necessary actions associated with (1) above and arrange a small civic reception for PC Phillips' family, friends, colleagues and some invited guests to take place on the rise of the Extra-Ordinary Council meeting in the Round Room of Wallasey Town Hall.

**HONORARY FREEDOM OF THE
BOROUGH (POSTHUMOUS AWARD) -
PC DAVID PHILLIPS (6554)**

Councillor Phil Davies, Leader of the Council, said:

'We were all shocked when we heard that 'one of our own,' Wirral PC David Phillips, had been killed while carrying out his duties in Wallasey last October.

'When we opened a Book of Condolence at Wallasey Town Hall, I was struck by the queues that formed to pay tribute to this brave and dedicated man, who had obviously made a huge impression on the people he worked with.

'He had served with Merseyside Police on Wirral for almost a decade, and as well as being a highly professional police officer, it was obvious from the comments that people left in our Books of Condolence, that he was kind, polite and very caring.

'He was very proud of being a police officer and carried out his job with bravery and professionalism.

'We know he was a devoted family man, and we hope that offering Freedom of the Borough will go some small way to comforting his family, and demonstrating how much we appreciate the dedication of PC Phillips and all serving police officers like him who are required to go 'above and beyond' on a daily basis during the course of their duties.

'We owe him a huge debt of gratitude for his bravery and courage in public service.'

REPORT SUMMARY

Under the Local Government Act 1972, the Council has the power to grant a person the title of Honorary Freeman or Freewoman of the Borough to persons of distinction who have rendered eminent service to the Borough.

PC David Phillips (6554), a 34 year old married father of two and resident of Wirral was a serving Merseyside Police Officer. He was on duty in Wallasey in the early hours of the morning on 5 October 2015 and died from internal injuries, when a vehicle he was trying to stop, hit him.

PC Phillips had served with Merseyside Police for approximately ten years and was an outstanding and well-respected Policeman. It is proposed to bestow the award of Freeman of the Borough (posthumously) on him.

This is a very significant step for the Council to take. Very few people have been awarded this status and, quite rightly, it should only be awarded to someone who has made an exceptional contribution to the Borough. PC Phillips is considered to be within this category.

In order to confer this honour on PC David Phillips the Council will need to pass a resolution by not less than two-thirds of the Members voting thereon at a meeting of the Council specially convened for the purpose, where notice of the object of the meeting has been given. A scroll will then be presented to Mrs Phillips by the Mayor.

The Phillips family and Merseyside Police have been consulted on a possible date for this meeting and it is proposed that the Council holds an Extra-Ordinary meeting for the purpose of bestowing this award (posthumously) on PC David Phillips at 6pm on Friday, 20 May 2016 in the Council Chamber at Wallasey Town Hall. It is also proposed that following this meeting, because of the very special circumstances, a small reception is held in the Round Room for the Phillips family and invited guests only.

RECOMMENDATION/S

That in pursuance of the provisions of Section 249(5) of the Local Government Act 1972 and in recognition of his dedicated service and bravery during his 10 years of employment with Merseyside Police, PC David Phillips be posthumously admitted as an Honorary Freeman of this Borough.

SUPPORTING INFORMATION

1.0 REASON/S FOR RECOMMENDATION/S

- 1.1 To honour PC David Phillips (posthumously) for his bravery and for his eminent service to the Police and the people of Wirral.
- 1.2 PC Phillips was born on 29 August 1981 in the Royal Devon and Exeter Hospital, Heavitree and moved to the Wirral from Devon in 1988. He lived in Greasby, Thingwall, Thornton Hough (1998 - 2007) and Bebington (2007 – 2015).
- 1.3 David Phillips was a Special Constable with Merseyside Police (based on the Wirral) from 10 January 2006 until 22 July 2006. He then joined the Police on a full time basis.

2.0 OTHER OPTIONS CONSIDERED

3.0 BACKGROUND INFORMATION

3.1 The origin of the Freedom of the Borough goes back to early medieval times, when with the growth of the great English towns, there emerged a class of citizen known as Freemen, who enjoyed important privileges in the government of their own and in the matter of corporate property, as against strangers and the rest of the inhabitants.

3.2 With the passing of the Honorary Freedom of the Boroughs Act 1885 the dignity attached to the Office of Freeman was revived and enhanced. This Act conferred upon all Municipal Corporations the power to admit as Honorary Freeman of the Borough "persons of distinction and any persons who have rendered eminent services to the Borough". This can only be achieved by the Council voting at a specially called meeting.

3.3 The Freedom of the Borough is the highest award the Council can bestow.

4.0 FINANCIAL IMPLICATIONS

4.1 The modest financial implications can be met from within existing budgets.

5.0 LEGAL IMPLICATIONS

5.1 The Council may by a resolution passed by not less than two-thirds of the Members voting thereon at a meeting of the Council specifically convened for the purpose with notice of the purpose, admit to be Honorary Freemen or Freewoman of the place or area for which it is the authority persons/organisations of distinction and persons/organisations who have in its opinion rendered eminent services to the Borough. (Section 249(5), of the Local Government Act 1972.)

6.0 RESOURCE IMPLICATIONS: STAFFING, ICT AND ASSETS

6.1 There are no implications associated with staffing, ICT or assets.

7.0 ENGAGEMENT / CONSULTATION

7.1 Merseyside Police has been consulted and is in favour of the proposals.
