REPORT SUMMARY

The purpose of this report is to consider an application to re-license the following vehicle: a Vauxhall Vectra, registration number YB06 POA, beyond the normal over-age date for a licensed private hire vehicle.

RECOMMENDATION/S

That the Panel consider whether or not to re-license this vehicle, registration number YB06 POA, for a further six months.

3.0 BACKGROUND INFORMATION

- 3.1 On 22 May 2013 Members of the Licensing Health and Safety and General Purposes Committee resolved that:
 - The maximum age for a vehicle to be licensed as a private hire vehicle be ten years from the date of first registration or manufacture, whichever is the earlier and that this Policy is to have immediate effect.
 - The Licensing Panel be delegated with the authority to act outside this policy.
- 3.2 Private hire vehicle licences are issued on a twelve monthly basis, however once a vehicle reaches six years old, six monthly licences are issued until the vehicle reaches ten years old.
- 3.3 The proprietor of the vehicle, Mrs Ellis-Brammer has applied to re-license her vehicle for a further six months.
- 3.4 The vehicle has been licensed as a private hire vehicle since 2 October 2014 and the current licence is due to expire on 27 December 2016.
- 3.5 The date of first registration of this vehicle is 28 June 2006.
- 3.6 On expiry of a previous licence on 27 June 2016 an application was considered by the Licensing Panel to grant a further six month licence and the application was granted.
- 3.7 The vehicle has been examined at one of the Council's authorised testing stations and the pass certificate will be available at the meeting.

- 3.1 On 22 May 2013 Members of the Licensing Health and Safety and General Purposes Committee resolved that:
 - The maximum age for a vehicle to be licensed as a private hire vehicle be ten years from the date of first registration or manufacture, whichever is the earlier and that this Policy is to have immediate effect.
 - The Licensing Panel be delegated with the authority to act outside this policy.
- 3.2 Private hire vehicle licences are issued on a twelve monthly basis, however once a vehicle reaches six years old, six monthly licences are issued until the vehicle reaches ten years old.
- 3.3 The proprietor of the vehicle, Mr Sutton has applied to re-license his vehicle for a further six months.
- 3.4 The vehicle has been licensed as a private hire vehicle since 15 June 2015 and the current licence is due to expire on 14 December 2016.
- 3.5 The date of first registration of this vehicle is 21 December 2006.
- 3.6 The vehicle has been examined at one of the Council's authorised testing stations and the pass certificate will be available at the meeting.

REPORT SUMMARY

The purpose of this report is to consider an application to exempt the following licensed Private Hire Vehicle: a DS5, registration number YH66 OAV, from displaying doorsigns when being used to fulfil a contract with licensed chauffeur companies.

RECOMMENDATION/S

That the Panel consider whether or not to provide the proprietor of the vehicle registration number YH66 OAV with a notice providing an exemption from the requirement to display doorsigns when being used to fulfil a contract with licensed chauffeur companies.

SUPPORTING INFORMATION

1.0 REASON/S FOR RECOMMENDATION/S

1.1 It is a delegated function of this Panel to determine matters relating to Private Hire Vehicle Licences where officers do not have delegated authority.

2.0 OTHER OPTIONS CONSIDERED

2.1 There is no provision for other options to be considered.

3.0 BACKGROUND INFORMATION

- 3.1 The vehicle is currently licensed as a Private Hire Vehicle. The conditions attached to the vehicle licence require that two doorsigns showing the name of the private hire company, the contact details of the company and the words "Private Hire Only" are displayed on the vehicle.
- 3.2 The proprietor of the vehicle, Mr Rushton, currently undertakes work for Abbey Taxis. Mr Rushton intends to apply for an Operator Licence and undertake his own work. Mr Rushton intends to also accept work from other licensed operators.
- 3.3 Mr Rushton has requested an exemption from displaying doorsigns when working for chauffeur companies due to the type of work undertaken.
- 3.4 There are currently two licensed operators who undertake work they describe as chauffeur work and operate vehicles under conditions which exempt the vehicles from displaying plates and doorsigns. The vehicles are non standard luxury vehicles used for occasional special journeys.
- 3.5 The vehicle will be available for inspection at the meeting.
