## **REPORT SUMMARY**

The purpose of this report is to consider an application for a Premises Licence under the provisions of the Licensing Act 2003. The application is made by **Tranmere Rovers Football Club Limited** and relates to the premises known as **Tranmere Rovers Football Club**, **Prenton Road West**, **Prenton**.

#### **RECOMMENDATION/S**

The Licensing Act 2003 Sub-Committee are asked to consider the application for a Premises Licence in respect of the above premises.

## 1.0 REASON/S FOR RECOMMENDATION/S

1.1 It is a statutory requirement for this Committee to determine the application due to relevant representations received.

## 2.0 OTHER OPTIONS CONSIDERED

2.1 There is no provision for other options to be considered.

## 3.0 BACKGROUND INFORMATION

- 3.1 These premises currently have a Premises Licence. Due to significant changes to the area to be included in the licence (the Plan) which includes an increase to the area for Licensable Activities, the applicant has submitted a new Premises Licence application. Plans of the Premises will be available at the Hearing.
- 3.2 The hours permitted on the current Premises Licence are as follows:

#### Live Music and Recorded Music

Sunday to Thursday	11:00 to 00:30
Friday and Saturday	11:00 to 01:30

#### **Non Standard Timings**

On any day when Tranmere Rovers first team are playing at home the above Licensable Activities to be extended until 01:00. 3.3 The application for a Premises Licence is as follows:

#### Sale by Retail of Alcohol

Sunday to Thursday 11:00 to 00:00 Friday and Saturday 11:00 to 01:00

#### **Regulated Entertainment**

Sunday to Thursday11:00 to 00:00Friday and Saturday11:00 to 01:00

#### Hours Open to the Public

Sunday to Thursday 11:00 to 00:30 Friday and Saturday 11:00 to 01:30

#### Late Night Refreshment

Sunday to Thursday23:00 to 00:30Friday and Saturday23:00 to 01:30

#### Non-Standard Timings

On any day when Tranmere Rovers first team are playing at home the above Licensable Activities (except for Late Night Refreshment) to be extended until 01:00.

On any day when Tranmere Rovers first team are playing at home Late Night Refreshment and Hours Open to the Public to be extended until 01:30.

Sale by Retail of Alcohol, Hours Open to the Public, Live Music, Recorded Music, Performance of Dance and Anything of a

Similar Description has been requested from the end of permitted hours on New Year's Eve to the end of permitted hours on New Year's Day.

Late Night Refreshment has been requested from 23:00 on New Year's Eve until 05:00 on New Year's Day.

#### 3.4 **PROMOTION OF LICENSING OBJECTIVES**

Applicants are required to submit as part of their application an operating schedule that sets out how they will conduct/manage their business to promote the four Licensing Objectives. A copy of the full application is available.

Members of the Licensing Act 2003 Sub-Committee are advised that the proposals set out in the operating schedule may become conditions of licence should the application be granted.

#### 3.5 **RELEVANT REPRESENTATIONS**

The following representations have been received in respect of the above application.

#### **Local Residents**

In respect of this application, a representation has been received from a Local Resident. A petition has also been received signed by 38 local residents who are against the application. The representation and petition relate to concerns that crime and disorder which is currently a problem within the vicinity of the premises will increase if the application is granted. The concerns also relate to noise nuisance being caused from the use of the marquee which is erected at the front of the stadium and noise which was caused during the Wirral Rocks event within the stadium earlier this year. Copies of the representation and petition are available.

#### **Merseyside Police**

A representation has been received from Merseyside Police who have concerns regarding the lack of clarity around the provision of CCTV cameras set out in the application and the use of glassware in the public concourse and during events at the stadium. A copy of the representation is available.

- 5.2 There are currently Planning restrictions that limit the use of the marque which has been erected at the front of the stadium. These restrictions are as follows:
  - The marquee hereby permitted shall be removed and the land restored to its former condition on or before 2 August 2017 in accordance with a scheme of work(s) to be submitted to and approved in writing by the Local Planning Authority.
  - The marquee hereby permitted shall be completely closed to members of the public between the hours of 23:30 – 08:30 (Monday to Friday); 00:30 – 08:30 (Saturday); 00:00 – 08:30 (Sundays and Bank Holidays).
  - No amplified music shall be played in the marquee hereby permitted between 23:00 and 09:00.
