REPORT SUMMARY

The purpose of this report is to consider an application for a Review of a Premises Licence under the provisions of the Licensing Act 2003. The application is made by a Local Resident and relates to the premises known as Slinky's, 84 Banks Road, West Kirby.

Live Music, Recorded Music and Anything of a Similar Description

Sunday to Saturday 10:00 to 00:00

Late Night Refreshment

Sunday to Saturday 23:00 to 00:00

- 3.2 The Licensing Act 2003 Sub-Committee may, having regard to the application for a Review and any relevant representations, take such of the following steps as it considers appropriate for the promotion of the licensing objectives:

- Modify the Conditions of the Licence.
- Exclude a licensable activity from the scope of the Licence.
- Remove the Designated Premises Supervisor.
- Suspend the Licence for a period not exceeding three months.
- Revoke the Licence.

The licensing authority may decide that no action is appropriate if it finds that the Review does not require it to take any steps that are appropriate to promote the licensing objectives.

3.3 APPLICATION

- 3.4 An application has been received from a Local Resident to review the Premises Licence for the premises known as Slinky's. The grounds for review are in relation to noise nuisance caused by customers of the premises inside and outside of the premises. The grounds are also in relation to nuisance from entertainment coming from the premises.
- 3.5 Further information to support the above grounds for the Review is included within the application which is available.

3.6 REPRESENTATIONS

Local Residents

In respect of this application, a representation has been received from a local resident who is in support of the application. The representation relates to noise nuisance and anti-social behaviour caused by customers of the premises. A copy of the representation is available.

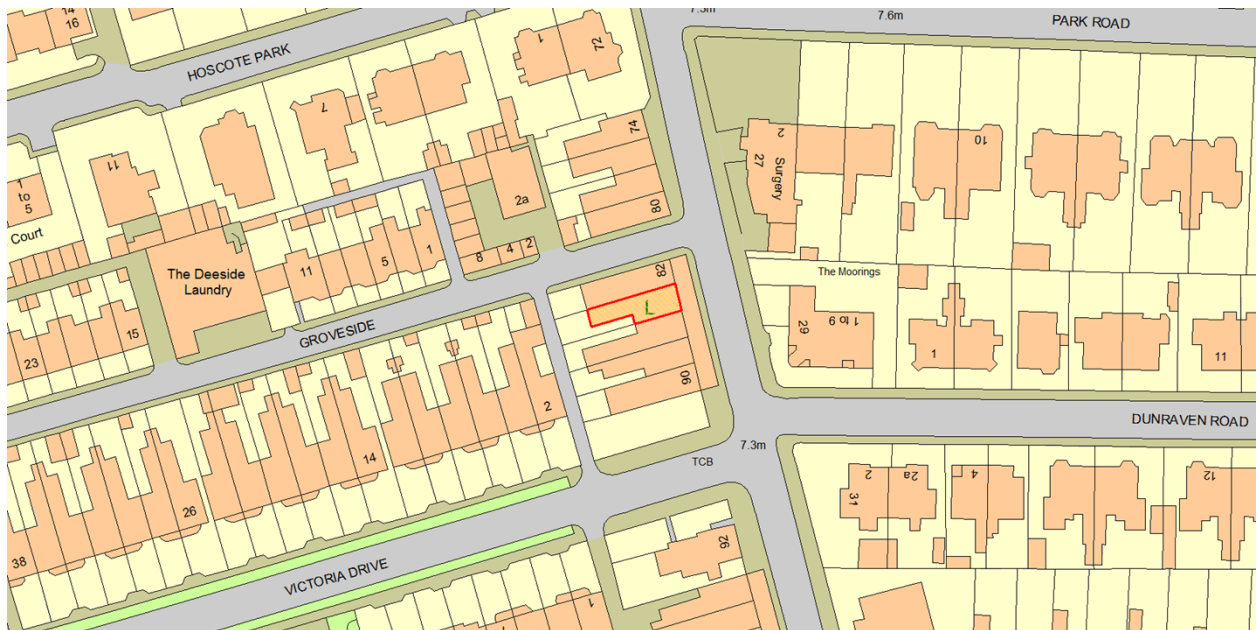
