REPORT SUMMARY

The purpose of this report is to inform Members of the Licensing Panel of an application for a Sexual Entertainment Venue Licence which has been granted under delegated authority following no representations in respect of a premises to be known as Peachez, Conway Street, Birkenhead. Members are asked to determine appropriate conditions to be placed on that licence.

RECOMMENDATION/S

That Members determine appropriate conditions to be placed on the Sexual Entertainment Venue Licence.

SUPPORTING INFORMATION

1.0 REASON/S FOR RECOMMENDATION/S

- 1.1 There is provision within The Local Government (Miscellaneous Provisions) Act 1982 for the Licensing Authority to determine appropriate conditions to be in place for a Sexual Entertainment Venue Licence.

2.0 OTHER OPTIONS CONSIDERED

- 2.1 No other options have been considered.

3.0 BACKGROUND INFORMATION

- 3.1 On 10 January 2011, Members of the Health and Safety and General Purposes Committee approved the adoption of the amendments to Schedule 3 of The Local Government (Miscellaneous Provisions) Act 1982, made by Section 27, paragraph 2(2) of Schedule 3 to the Policing and Crime Act 2009.
- 3.2 Section 27 of The Policing Crime Act 2009 defines a new category of sex establishment namely 'Sexual Entertainment Venue' which provides the means for local authorities to regulate lap dancing clubs and similar venues under Schedule 3 of The Local Government (Miscellaneous Provisions) Act 1982 and gives local authorities more powers to control the number and location of these types of premises.
- 3.3 These premises, Peachez, Conway Street, Birkenhead which was previously known as Filthy McNasty's currently has a Premises Licence with the following permitted hours:

Sale by Retail of Alcohol

Sunday to Thursday	10:00 to 04:00
Friday and Saturday	10:00 to 05:00

Live Music

Sunday to Thursday	20:00 to 04:00
Friday and Saturday	20:00 to 05:00

Recorded Music and Anything of a Similar Description

Sunday to Thursday	10:00 to 04:00
Friday and Saturday	10:00 to 05:00

Late Night Refreshment

Sunday to Thursday	23:00 to 04:00
Friday and Saturday	23:00 to 05:00

Hours Open to the Public

Sunday to Thursday 10:00 to 04:30
Friday and Saturday 10:00 to 05:30

5.0 APPLICATION

5.1 An application for a Sexual Entertainment Venue Licence has been submitted by David Doyle in respect of these premises. The nature of the relevant entertainment includes lap dancing, pole dancing and strip shows to take place between the following hours:

Sunday to Saturday 21:00 to 05:00

5.2 Following no representations in respect of the application this application has been granted under delegated authority.

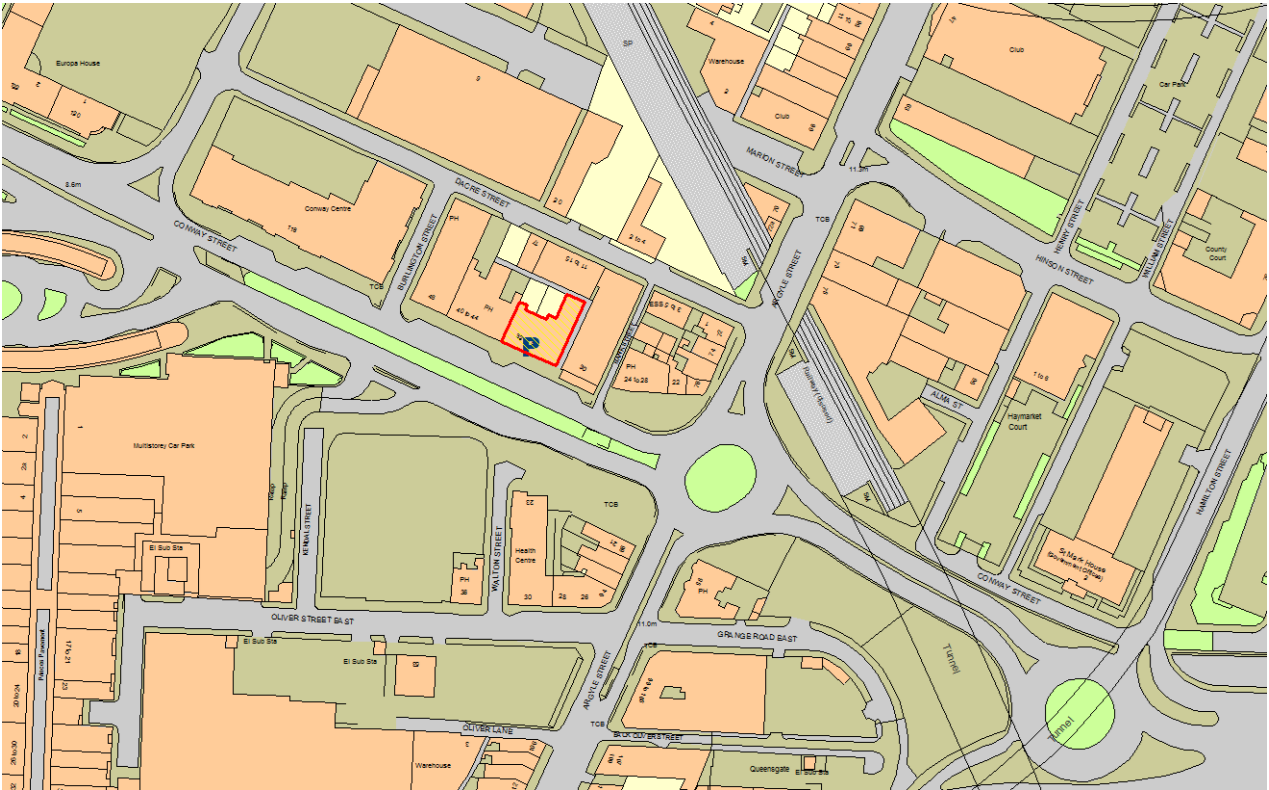
