REPORT SUMMARY

The purpose of this report is to consider an application to re-license a Toyota Prius, registration number SD58 CPN, beyond the normal over-age date for a licensed Private Hire Vehicle.

RECOMMENDATION/S

That the Licensing Panel considers whether or not to re-license the vehicle for a further six months.

SUPPORTING INFORMATION

1.0 REASON/S FOR RECOMMENDATION/S

1.1 It is a delegated function of this Panel to determine applications for Private Hire Vehicle Licences where the vehicle is over ten years old.

3.0 BACKGROUND INFORMATION

- 3.1 Private Hire Vehicle Licences are issued on a twelve monthly basis until a vehicle reaches six years old, when six-monthly licences are issued until the vehicle reaches ten years old.
- 3.2 The proprietor of the vehicle, Mr Ashurst, has applied to re-license his vehicle for a further six months.
- 3.3 The vehicle has been licensed as a Private Hire Vehicle since 21 August 2013 and the current licence is due to expire on 20 February 2020.
- 3.4 The date of first registration of this vehicle is 30 September 2008.
- 3.5 On expiry of previous licences on 20 August 2018, 20 February 2019 and 20 August 2019 applications were considered by the Licensing Panel to grant a six month licence and the applications were granted.
- 3.6 The vehicle has been examined at one of the Council's authorised testing stations and the pass certificates will be available at the meeting.
- 3.7 The vehicle will be available for inspection at the meeting.
