REPORT SUMMARY

The purpose of this report is to consider an application to license a Toyota Prius, registration number JC56 ASH, beyond the normal over-age date for a licensed Private Hire Vehicle.

RECOMMENDATION/S

That the Licensing Panel considers whether or not to license the vehicle for six months.

1.0 REASON/S FOR RECOMMENDATION/S

1.1 It is a delegated function of this Panel to determine applications for Private Hire Vehicle Licences where the vehicle is over ten years old.

- 3.1 Private Hire Vehicle Licences are issued on a twelve monthly basis until a vehicle reaches six years old, when six-monthly licences are issued until the vehicle reaches ten years old.
- 3.2 The proprietor of the vehicle, Mr Ashdown, has applied to license the vehicle for six months.
- 3.3 The vehicle was previously licensed as a Private Hire Vehicle from 8 May 2108 until 25 June 2020 when the licence was not renewed.
- 3.4 The date of first registration of this vehicle is 15 October 2010.
- 3.5 The vehicle has been examined at one of the Council's authorised testing stations and the pass certificates will be available at the meeting, together with photographs of the vehicle.

REPORT SUMMARY

The purpose of this report is to consider an application to license the following vehicle, namely an LTI TX4, registration number BF09 TXN, as a Hackney Carriage Vehicle.

RECOMMENDATION/S

That the Panel considers whether or not to license the vehicle registration number BF09 TXN as a Hackney Carriage Vehicle.

SUPPORTING INFORMATION

1.0 REASON/S FOR RECOMMENDATION/S

1.1 It is a delegated function of this Panel to determine applications for Hackney Carriage Vehicle Licences where the vehicle cannot comply with the current criteria for licensing Hackney Carriage Vehicles.

2.0 OTHER OPTIONS CONSIDERED

2.1 That the application be refused.

3.0 BACKGROUND INFORMATION

- 3.1 The current criteria for licensing Hackney Carriage Vehicles includes a requirement that:
 - "...every vehicle must be three years old or less from the date of first registration or date of manufacture (whichever is the earlier)".
- 3.2 The proprietor of the vehicle, Wirral Car Solutions Ltd, has applied for the grant of a Hackney Carriage Vehicle Licence.
- 3.3 The date of first registration of the vehicle is 25 March 2009 and the vehicle is therefore over three years old.
- 3.4 The vehicle was previously licensed as a Hackney Carriage Vehicle from 28 June 2013 until 27 June 2020 when the licence was not renewed. The vehicle was then purchased by Wirral Car Solutions Ltd.
- 3.5 The vehicle has been tested at one of the Council's authorised testing stations and the pass certificates will be available at the meeting together with photographs of the vehicle.
- 3.6 The Panel is asked to consider the application and determine if there is good reason to act outside of the current policy and license the vehicle, registration number BF09 TXN, as a Hackney Carriage Vehicle.

3.1 On 22 May 2013 Members of the Licensing Health and Safety and General Purposes Committee resolved that:

"In circumstances when a Hackney Carriage Vehicle proprietor wishes to change a Hackney Carriage Vehicle that is currently licensed to a different vehicle, the replacement vehicle must be the same age or less than the vehicle that is currently licensed up to a maximum of ten years old. Vehicles that are ten years old or more must be replaced by a vehicle that is no more than ten years old and that this Policy is to have immediate effect.

The Licensing Panel be delegated with the authority to act outside this policy."

- 3.2 In accordance with the resolution in paragraph 3.2 Members are asked to consider the application submitted by the applicant, Mr Higgins, to change the vehicle that is currently licensed as a Hackney Carriage Vehicle, registration number T946 BFM which is 21 years old, to the vehicle registration number LB54 OSN which is 15 years old.
- 3.3 The current vehicle is due to expire on 24 September 2020.
- 3.4 Members are asked to consider the application and determine if there is good reason to act outside of the current policy and license the vehicle, registration number LB54 OSN as a Hackney Carriage Vehicle.
- 3.5 The vehicle has been examined at one of the Council's authorised testing stations and the pass certificates will be available at the meeting, together with photographs of the vehicle.
