REPORT SUMMARY

In respect of this application, a representation has been received from a Local Resident. The representation relates to concerns that anti-social behaviour will increase if this application is granted due to customers leaving the premises late at night causing a nuisance which the resident has indicated is currently a problem with other nearby premises. The resident also has concerns regarding the use of the outside area at the rear of the premises which could cause a nuisance to local residents. A copy of the representation is available.

3.5 In response to the representation submitted by the local resident, the agent representing the applicant has written to the resident outlining how the premises will be operated if the application is granted. A copy of this letter is available.
