GENERAL EXCEPTION NOTICE – MEADOWSIDE SCHOOL

EXPLANATORY NOTES

- (1) The Council publishes a Forward Plan of key decisions it expects to take over the next four months giving at least 28 days' notice of decisions. The Forward Plan is available to view on the Council's website under the heading, 'Council and Democracy' and 'Minutes, Agendas and Reports'.

- (3) The Decision will be treated as a General Exception on the grounds that the Wirral Home School service are dealing with very challenging students and we need to provide suitable accommodation for them to meet their needs and Wirral's responsibilities in this area.
