DAVE MITCHELL

1. Para 4.1 of the report

What would happen to a petition, from a small estate or even an isolated road, that could not reach the required number?.

ANN BRIDSON

Draft Petition Scheme (Pages 8 and 9)

Pg 8 (Introduction) mentions 'acknowledgement within 14 days of receipt' while Pg 9 mention 'within 10 working days'. The same timescale should be used. (There are other examples later).

2. Composition of the Scrutiny Programme Board

Pg 9 last para, Scrutiny Programme Board –including **Chairs** of O&S Committees. Is this a fixed arrangement? (I think that the membership of the Scrutiny Programme does not <u>have to</u> include the other five Chairs)

E-Petitions

I have some reservations about an electronic petition, may lead to frivolous petitions, easy to collect signatures without considered effort. Can we put in any safeguards?

ALAN VEITCH

How will the Council respond to petitions? (Page9)

Who decides on the relevant response?

Should there be a time limit by which the follow-up action should take place? (for example, a meeting take place or research be undertaken, etc..)

E-Petitions (Page 11)

Final paragraph states "If you would like to present your e-petition to a meeting of the Council please contact the Democratic Services Manager within five days of the petition closing". That is a very short timescale.

3. E-Petitions (Para 5.2)

I have read that Lambeth are well established using Mod.Gov - so they may have advice.
