REPORT OF THE DIRECTOR OF CHILDREN'S SERVICES

School Balances

EXECUTIVE SUMMARY

This report is for information only and advises the Forum of the school balances as at 31^{st} March 2010. The balances have reduced from £9.2m to £8.4m. This represents a year on year reduction of £0.8m (8%).

1. Summarised Balances

Total balances include Standards Fund carry forwards, which can be spent until the following August. An amount of £104,000 has been capitalised from 3 schools' revenue budgets towards capital projects.

The Standards Fund element of the carry forward above has reduced from £3.3m to ± 3.0 m as at 31^{st} March 2010.

From 2011/12 the DfE have proposed that a number of grants, including School Development Grant and School Standards Grant, will form part of the DSG.

2. Deficit Budgets

There are a number of schools who were in deficit as at 31st March 2010; the table below details the number of schools in deficit and the total amount. The numbers in brackets detail the schools in deficit as at 31st March 2009.

The average secondary school deficit has increased from £141,000 to £246,000 Some of the schools with deficit balances in March 2010 have set balanced budgets for 2010/11 financial year. There are 14 schools that have or are seeking a licensed deficit in this financial year, compared to 10 last year.

4. Excess Balances

Five schools have an excess balance above the 5 or 8%, after standards and cluster funds have been deducted. The table below details the amounts to be deducted, based on the 5% levy set for 2009/10 balances. Excess deductions made up to 31st March 2009 are £136,499. A decision on how this will be re-allocated will be taken at the end of the funding period. DfE guidance suggests the use of clawback funds for invest to save priorities.
