1.0 EXECUTIVE SUMMARY

1.1 The purpose of this report is to consider an application for the review of a Premises Licence under the provisions of the Licensing Act 2003. The application is made by Merseyside Police and relates to the premises known as the **Punch Bowl, 77 Market Street, Hoylake**.

2.0 BACKGROUND AND KEY ISSUES

2.1 The Punch Bowl currently has a Premises Licence, to allow the following Licensable Activities:

Sale by Retail of Alcohol

Sunday to Saturday 10:00 to 00:00

Hours Open to the Public

Sunday to Saturday 10:00 to 00:30

Regulated Entertainment (Live Music)

Sunday to Saturday 12:00 to 00:00

Regulated Entertainment (Exhibition of Films, Performance of a Play, Performance of Dance, Recorded Music, Indoor Sporting Events and Anything of a Similar Description)

Sunday to Saturday 10:00 to 00:15

Entertainment Facilities (Facilities for Making Music and Dancing)

Sunday to Saturday 10:00 to 23:00

Late Night Refreshment

Sunday to Saturday 23:00 to 00:15

2.2 The Licensing Act 2003 Sub-Committee may, having regard to the application for review and any relevant representations, take such of the following steps as it considers necessary for the promotion of the licensing objectives:

- Modify the Conditions of the Licence.
- Exclude a licensable activity from the scope of the Licence.
- Remove the Designated Premises Supervisor.
- Suspend the Licence for a period not exceeding three months.
- Revoke the Licence.

The licensing authority may decide that no action is necessary if it finds that the review does not require it to take any steps necessary to promote the licensing objectives.

3.0 APPLICATION

3.1 An application has been received from Merseyside Police to review the Premises Licence for the premises known as the Punch Bowl. The Licensing Sergeant has advised that the grounds for review are in relation to the Prevention of Crime and Disorder and Public Safety due to gas at the premises being illegally abstracted.

3.2 Further information to support the above grounds for review is included within the application which is available.
