### 1.0 EXECUTIVE SUMMARY

1.1 The purpose of this report is to consider an application for the review of a Premises Licence under the provisions of the Licensing Act 2003. The application is made by Merseyside Police and relates to the premises known as **Al Verona Pizza, 188 Brighton Street, Wallasey.**

### 2.0 BACKGROUND AND KEY ISSUES

2.1 Al Verona Pizza currently has a Premises Licence, to allow the following Licensable Activity:

#### **Late Night Refreshment**

Sunday to Thursday 23:00 to 00:30  
Friday and Saturday 23:00 to 01:30

#### **Hours Open to the Public**

Sunday to Thursday 16:00 to 00:30  
Friday and Saturday 16:00 to 01:30

2.2 The Licensing Act 2003 Sub-Committee may, having regard to the application for review and any relevant representations, take such of the following steps as it considers necessary for the promotion of the licensing objectives:

- Modify the Conditions of the Licence.
- Exclude a licensable activity from the scope of the Licence.
- Remove the Designated Premises Supervisor.
- Suspend the Licence for a period not exceeding three months.
- Revoke the Licence.

The licensing authority may decide that no action is necessary if it finds that the review does not require it to take any steps necessary to promote the licensing objectives.

### **3.0 APPLICATION**

- 3.1 An application has been received from Merseyside Police to review the Premises Licence for the premises known as Al Verona Pizza. The Licensing Sergeant has advised that the grounds for review are in relation to the Prevention of Crime and Disorder and Public Safety due to electricity and gas at the premises being illegally abstracted.
- 3.2 Further information to support the above grounds for review is included within the application which is available.
