1.0 EXECUTIVE SUMMARY

1.1 The purpose of this report is to consider an application for the review of a Premises Licence under the provisions of the Licensing Act 2003. The application is made by Merseyside Police and relates to the premises known as **Ruhi Balti House, 94 Woodchurch Lane, Prenton**.

2.0 BACKGROUND AND KEY ISSUES

2.1 Ruhi Balti House currently has a Premises Licence, to allow the following Licensable Activities:

Supply of Alcohol

Sunday to Thursday 17:30 to 23:00 Friday and Saturday 17:00 to 00:00

Late Night Refreshment

Friday and Saturday 23:00 to 00:00

Hours Open to the Public

Sunday to Thursday 17:30 to 23:30 Friday and Saturday 17:00 to 00:30

- 2.2 The Licensing Act 2003 Sub-Committee may, having regard to the application for review and any relevant representations, take such of the following steps as it considers appropriate for the promotion of the licensing objectives:
 - Modify the Conditions of the Licence.
 - Exclude a licensable activity from the scope of the Licence.
 - Remove the Designated Premises Supervisor.
 - Suspend the Licence for a period not exceeding three months.
 - Revoke the Licence.

The licensing authority may decide that no action is appropriate if it finds that the review does not require it to take any steps appropriate to promote the licensing objectives.

3.0 APPLICATION

- 3.1 An application has been received from Merseyside Police to review the Premises Licence for the premises known as Ruhi Balti House. Merseyside Police have advised that the grounds for review are in relation to the Prevention of Crime and Disorder and Public Safety due to electricity and gas at the premises being illegally abstracted. Merseyside Police have also advised that a number of illegal immigrants were being employed at the premises. Merseyside Police also has concerns regarding health and safety issues within the kitchen at the premises.
