1.0 EXECUTIVE SUMMARY

- 1.1 The purpose of this report is to consider an application for a Premises Licence under the provisions of the Licensing Act 2003. The application is made by **Balvinder Grewal** and relates to the premises located at **181-183 Kings Road, Bebington**.

Sale by Retail of Alcohol

Monday to Saturday 08:00 to 22:00
Sunday 10:00 to 22:00

Hours Open to the Public

Sunday to Saturday 06:00 to 22:00

- 2.2 This Premises Licence was surrendered in August 2011 when the previous business at this address ceased trading.

- 3.1 An application has been received for the grant of a Premises Licence for the premises located at 181-183 Kings Road, Bebington for the following hours:

Sale by Retail of Alcohol

Sunday to Saturday 08:00 to 23:00

Hours Open to the Public

Sunday to Saturday 06:00 to 23:00

- 3.2 The applicant originally requested for the sale by retail of alcohol to start from 06:00 but amended the application as above following consultation with Merseyside Police.

- 4.1 Applicants are required to submit as part of their application an operating schedule that sets out how they will conduct/manage their business in accordance with the four Licensing Objectives. A copy of the full application is available.

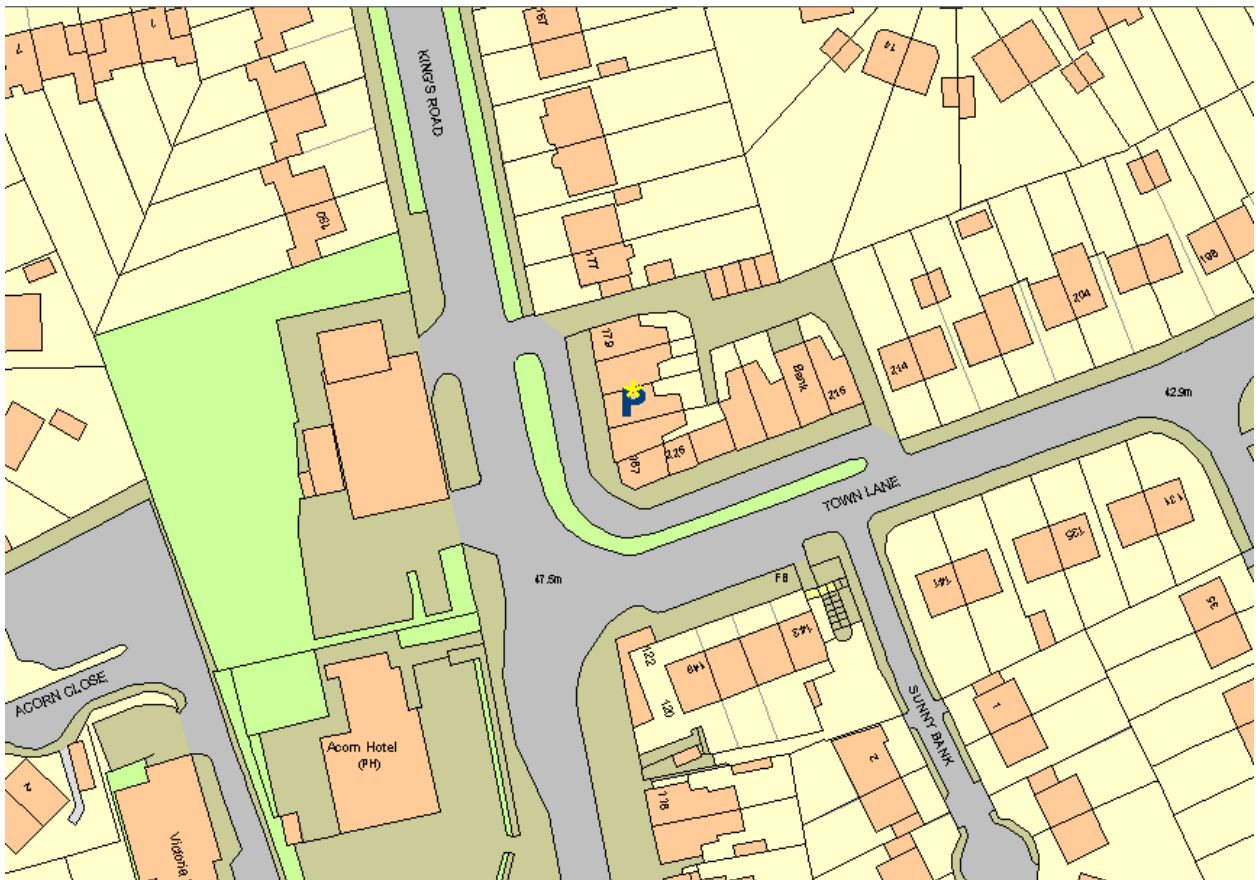
