This includes everyone who lives, works or has an interest in the Borough, together with local landowners, businesses and service providers, irrespective of their gender, faith, race, disability, sexuality, age or income.”				
All Groups	Paragraph 2.8, which states that “any person is entitled to make representations about an emerging local development document or about a planning application, before it is determined, provided the comments are made within the published period for comments to be received, is considered to have a positive impact on all groups.

All Groups	<p>Paragraph 2.10 to 2.13 – Equality and Diversity, which set out the aspiration to ensure that local consultation exercises are undertaken amongst a wider set of individuals than just those participating in established interest groups and to be fully representative of those who live, work or carry out business in the area, are considered to have a positive effect on all groups. Paragraph 2.11 sets out the need to identify methods to involve more ‘hard to reach’ groups such as the young, disabled, ethnic minorities, residents in deprived areas and gypsies and travellers; and paragraph 2.13 sets out how the Council will seek to minimise barriers to effective participation by giving people access to enough background information to enable a meaningful response; ensuring documents, letters and emails use plain English and avoid the use of unnecessary jargon; provide a consultation questionnaire to help people to frame their responses to more lengthy or complicated issues; ensuring venues for public meetings are genuinely accessible to the target community and provide appropriate facilities, such as induction loops, disabled access and toilets.</p>				All Groups

All Groups	Paragraph 3.18, which states that during early stages of consultation, emphasis will be on making simple background information as widely available as possible in a variety of formats and on presenting information on potential options to a series of invited audiences in focus groups and other forms of public meeting including Open Days and that more focused, targeted consultations may also need to be undertaken with 'hard-to-reach' groups, is considered to have a positive impact upon all groups.

All Groups	Paragraph 3.21, which refers to statutory procedures at the public examination of local development documents, is considered to have a positive impact upon all groups, as it makes it clear that anyone who makes representations seeking a change to the proposed submission draft local plan must be given the opportunity to appear and be heard by the person appointed to carry out the public examination.				
All Groups	Paragraph 3.37 is considered to have a positive impact upon all groups, as it will allow the Council to identify the most appropriate methods to involve and engage the community at a scale and nature of consultation that is appropriate to the audience, as each local development document is being prepared.				
All Groups	Paragraph 3.55 is considered to have a positive impact upon all groups, as the Council will investigate the possibility of providing documents in different formats in response to specific requests.				
All Groups	Paragraph 3.57 is considered to have a positive impact upon all groups, as it states that any person may make representations about the emerging content of a local development document.

All Groups	Paragraphs 4.56 and 4.57 are considered to have a positive impact on all groups, as they encourage landowners and developers to undertake their own pre-application community consultation, especially for large, complex or controversial proposals and for proposals that will be contrary to the Development Plan. They also set out the advantages of early involvement of the community including allowing proposals to be explained, assisting in gauging community support, obtaining accurate local information, clarifying the issues at debate, providing greater certainty and transparency, saving time later in the decision making process and the delivery of a more acceptable development.

Race, Disability, Age	Paragraph 5.1 is considered to have a positive impact on the following groups protected under the Equality Duty 2010 under the headings of race, disability and age, as it sets out the type of bodies and organisations that are currently consulted on the preparation of local plans and supplementary documents, which specifically includes the Disability Action Forum, Age UK, the Wirral Older People's Parliament, Black and Ethnic Minority Groups and Gypsy and Traveller Organisations.

Statutory reports of consultation will be prepared and published at each stage in the preparation of a local development document, to ensure that the requirements of the SCI have been complied with.

Records of people consulted on planning applications are kept on a Development Management database and responses are recorded on individual planning application files.

The Statement of Community Involvement (SCI) sets out what the Council will do to meet the requirements for community involvement in planning decisions set out in national legislation. The SCI represents the Council's commitment to facilitate early community involvement when local planning policies are being drawn up and to promote continuous community involvement in local planning decisions. The SCI aims to ensure that everyone who wants to is able to contribute to planning decisions, irrespective of their gender, faith, race, disability, sexuality, age or income and that special efforts are taken to obtain a contribution from 'hard-to-reach' groups when Council policies are being drawn up. As a result, there is considered to be no negative impact resulting from the SCI.
