Summary of Paper	<p>Two years ago, a Panorama programme provided a shocking illustration of the vulnerability of people in hospitals like Winterbourne View. As a result the Department of Health has set up a programme for change and through this the Government has given a mandate to the NHS Commissioning Board which states that:</p> <p>“The NHS Commissioning Board’s objective is to ensure that CCGs work with local authorities to ensure that vulnerable people, particularly those with learning disabilities and autism, receive safe, appropriate, high quality care. The presumption should always be that services are local and that people remain in their communities; we expect to see a substantial reduction in reliance on inpatient care for these groups of people.”</p> <p>In summary, this means:</p> <ul style="list-style-type: none"> • all current placements will be reviewed by 1 June 2013, and everyone inappropriately in hospital will move to community-based support as quickly as possible, and no later than 1 June 2014; • by April 2014 each area will have a locally agreed joint plan to ensure high quality care and support services for all children, young people and adults with learning disabilities or autism and mental health conditions or behaviour described as challenging, in line with the model of good care

WINTERBOURNE VIEW STOCKTAKE

1. Background

Winterbourne View was a really important service failure that has received significant national attention. There is a National Improvement Programme being run jointly through a programme board run by NHS England and the LGA based on a concordat agreement. There are 75 recommendations to unravel sequence and order.

Key themes include;

- Moving the money around the system effectively to provide appropriate support
- Safeguarding people in less restrictive environments
- Provider development and market management
- Life course planning to improve transition planning

A national stock take has been issued and Wirral is completing this as part of a national picture of what is required to get up to pace. We currently have a group of officers working very hard to complete the Stock take and the Wirral response to Winterbourne. The group is made up of DASS, NHS, CWP and CYPD officers to ensure a consistent and cohesive approach. We are working through the measures and data tools to ensure a consistent understanding and approach to providing evidence, to share good practice and to consider if there are opportunities to work together more strategically on any aspect of the action plan and self-assessment with neighbouring authorities.

In summary, the Stocktake is an essential step in the Winterbourne View Joint Improvement Programme established by NHS England and the LGA to coordinate the delivery of the commitments in the Winterbourne Concordat (December 2012) we will be participating fully in this and ensuring appropriate implementation of action plans on Wirral.
