For respite and short term placements (less than 8 weeks) Local Authorities may set a reasonable charge. Following financial assessment, service users may be assessed to pay the full cost of respite. The charge for 2015/16 will be determined by the increase in the Retirement Pension and Personal Allowance, which is not yet known.

The nursing and NEMI figures for 2013-14 and 2014-15 do not include the NHS contribution to a nursing home place. This was £109.79 per week in 2013/14 and £110.89 per week in 2014/15. This part of the package cost is free to the service user and is not financially assessed.

#### **Before You Build**

You or your agent must advise the Council of your intentions either by submitting a Full Plans Application or a Building Notice. The Charge payable depends on the type of commercial works, and / or the total floor area. The following table may be used in conjunction with the Wirral Council Scheme of Charges to calculate the appropriate fee(s) for Building Control Applications.

## Charges are payable as follows:-

## **Full Plans Applications:**

Plan Charge – Payable at time of submission to cover the plan assessment and decision on the application. Inspection Charge (If Applicable) – Payable following first site inspection covering all site inspections.

## **Building Notice:**

In most circumstances a Building Notice will not be applicable for works carried out under Schedule 3. However, if a Building Notice is to be allowed, with prior agreement of Wirral Council, the Building Notice Charge is the excl vat Plan charge + excl vat Inspection charge + 10% (Building Notice Surcharge).

#### Regularisation

If you apply for a Regularisation Certificate, in respect of unauthorised building work, commenced on or after 11th November 1985, you will pay a regularisation charge cost for assessing your application and all inspections. This charge is equivalent to the excl vat Building Notice Charge + 40% (Regularisation Surcharge) (VAT is not applicable on a regularisation application)

Please note this fee is not refundable once we have undertaken our first site inspection and you then decide not to proceed further with your application.

### Individually determined charges:

Where any proposed work falls out side of these standard charges, the charge will be determined individually on request.

#### Payment methods:

Cash – in person at our offices

Debit / credit card - in person at our Offices or telephone 0151-691-8454

Cheques - made payable to Wirral Council.

## **Notes**

### 1. Reduction Factors

Where works identified in Table E below as E1 – E3, E6 and E7, is undertaken on the same application and at the same time as extension work identified in Table D, then a 50% reduction of these Table E charges, will be applied.

#### 2. Floor Area:

The total combined floor area, of all storeys, calculated by reference to the finished internal faces of the walls enclosing the area, or if at any point there is no enclosing wall, by reference to the outermost edge of the floor.

## 3. Estimates of Costs:

A reasonable amount that would be charged for carrying out that building work, by a person in business to carry out such work. (VAT and any professional fees paid to an architect or surveyor should be excluded.)
