REPORT SUMMARY

The purpose of this report is to consider an application for a Premises Licence under the provisions of the Licensing Act 2003. The application is made by **Sukhnandan Jit Kaur** and relates to the Premises known as **MK Convenience Store, 391 Borough Road, Birkenhead**.

Applicants are required to submit as part of their application an operating schedule that sets out how they will conduct/manage their business in accordance with the four Licensing Objectives. A copy of the full application is available.

In respect of this application, a representation has been received from a Local Resident who has concerns with underage drinking within the vicinity of the premises. A copy of the representation is available.

Ward Councillor

A representation has been received from Ward Councillor, Pat Cleary, who has concerns with the problem of street drinking within the area in which the premises are located. A copy of the representation is available.

Public Health

A representation has been received from Public Health which relates to concerns that the availability of alcohol at this particular location where deprivation is high and the density of licensed premises is high could undermine each of the four Licensing Objectives. A copy of the representation is available.

Trading Standards

A representation has been received from Trading Standards who have concerns that the applicant has limited understanding of the Licensing Act 2003 and will not be able to uphold the Licensing Objectives. A copy of the representation is available.

Environmental Health

A representation has been received from Environmental Health who have concerns that the applicant has limited understanding of the Licensing Act 2003 and will not be able to uphold the Licensing Objectives. A copy of the representation is available.
