REPORT SUMMARY

The purpose of this report is to consider an application to re-license a Vauxhall Vectra, registration number MF57 ZYJ, private hire vehicle licence number 55, beyond the age which private hire vehicles would normally be licensed.

RECOMMENDATION/S

That the Licensing Panel consider whether or not to re-license this vehicle, registration number MF57 ZYJ, for a further six months.

SUPPORTING INFORMATION

1.0 REASON/S FOR RECOMMENDATION/S

- 1.1 It is a delegated function of this Panel to determine applications for private hire vehicle licences where the vehicle is over ten years old.

2.0 OTHER OPTIONS CONSIDERED

- 2.1 There is no provision for other options to be considered.

3.0 BACKGROUND INFORMATION

- 3.1 On 22 May 2013 Members of the Licensing Health and Safety and General Purposes Committee resolved that:

- 1 The maximum age for a vehicle to be licensed as a private hire vehicle be ten years from the date of first registration or manufacture, whichever is the earlier and that this Policy is to have immediate effect.
- 2 The Licensing Panel be delegated with the authority to act outside this policy.

- 3.2 Private hire vehicle licences are issued on a twelve monthly basis, however once a vehicle reaches six years old, six monthly licences are issued until the vehicle reaches ten years old.

- 3.3 The proprietor of the vehicle, Mr McKeown has applied to re-license his vehicle for a further six months.

- 3.4 The vehicle has been licensed as a private hire vehicle since 25 June 2015 and the current licence was due to expire on 30 October 2017, however it has been extended to the date of this meeting.

- 3.5 The date of first registration of this vehicle is 30 October 2007.

- 3.6 The vehicle has been examined at one of the Council's authorised testing stations and the MOT and Compliance Test certificates will be available at the meeting.
